#### **NOTICE OF PROHIBITION**

WHEREAS on or about March 6, 2009, Keona Blagburn ("Blagburn") pleaded guilty to Embezzlement, VA CODE ANN. §§ 18.2-11; and Obtaining Money Under False Pretenses, § 18.2-178, in connection with her employment at Newport News Neighborhood FCU, in Newport News, Virginia;

WHEREAS the violations are criminal offenses involving dishonesty and breach of trust;

#### NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

- 1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Blagburn is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;
- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Blagburn to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;

- 3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both;
- 4. The "Newport News Circuit-Criminal Division Case Details" filed March 31, 2010, CR1000006-00, is made a part hereof and is incorporated herein by reference; and
- 5. This Notice of Prohibition shall be effective and enforceable on the date of set forth below.
