



Current NAAQS Review Process





NAAQS in 2011

- O₃ Reconsideration Final decision July 2011
- New periodic O₃ Review First draft ISA in March 2011
- NO₂/SO₂ secondary standards Proposal July 12, 2011
- CO Final decision August 12, 2011
- PM Proposal in 2011
- Lead Draft Plan and first draft ISA Spring 2011
- NO₂ and SO₂ primary standards Schedules under development



Ozone NAAQS Reconsideration

- Reconsideration of standards that were issued in 2008.
 - To ensure they are clearly grounded in science, protect public health with an adequate margin of safety, and are sufficient to protect the environment.
- Proposal signed January 6, 2010
 - Would strengthen the level of the 8-hour primary ozone standard to a level within the range of 0.060-0.070 parts per million (ppm).
 - Would establish a distinct cumulative, seasonal secondary standard at a level in the range of 7-15 ppm-hours.
- Three public hearings and 60 day public comment period
- Final Rule to be signed by the end of July 2011

CO NAAQS

- On January 28, 2011, EPA proposed to retain the existing NAAQS for CO
 - EPA concludes that the current standards provide the required level of public health protection, including protection for people with heart disease, who are especially susceptible to health problems associated with exposure to CO in ambient air
- The existing primary standards are 9 parts per million (ppm) as an 8-hour average, and 35 ppm as a 1-hour average, neither to be exceeded more than once per year
- There is no secondary (welfare-based) NAAQS for CO
 - Lack of evidence of direct effects on public welfare at ambient concentrations
 - EPA is proposing that the current evidence does not provide support for establishing secondary CO standards
- Notice of proposed rulemaking was published in the FR on Feb 11, 2011
 - Public hearing was held on February 28, 2011
 - EPA will accept comments for a 60 day period, which closes on April 12, 2011
 - EPA must issue a final rule by August 12, 2011



PM NAAQS

- Integrated Science Assessment: December 2009
 - Synthesis and assessment of most policy-relevant science
- Risk/Exposure Assessments: June/July 2010
 - Focus on fine particles and did not assess risks associated with coarse particles
- Policy Assessment: Second draft released June 2010
 - Staff conclusions of broadest range of policy options supported by the available scientific evidence, quantitative assessments, and air quality analyses
- Drafts of each document have been reviewed by CASAC and the public
 - Final documents take into consideration CASAC and public comments
- Next steps:
 - Finalize Policy Assessment
 - Propose Rule with 90-day public comment period
 - Issue Final Rule
