## Chart Name: APPLICATIONS FOR IMMIGRATION BENEFITS

What it DISPLAYS: The below chart provides data on applications and petitions received by USCIS for immigration benefits in February 2012. This chart excludes all data associated with the citizenship related applications.

What it Shows: Immigration application receipts increased 86 percent compared to the number received in February 2011. February 2012 approvals increased by 54 percent, denials decreased by 9 percent, and pending increased by 33\% compared to February 2011.
