Hispanic and Women Farmers and Ranchers Discrimination Claim Period Opens

Agriculture Secretary Tom Vilsack has announced the opening of the claim period for Hispanic and Women Farmers and Ranchers that allege discrimination during the period 1981 thru 2000. CRP and DCP Payments

CRP annual rental payments will begin on or about October 2, 2012. Please keep in mind that rental reductions for CRP haying and grazing may be deducted from your rental payments.

FSA will begin issuing DCP and ACRE direct payments for 2012 participants on October 9, 2012. ACRE revenue payments for 2011 crops, if earned, will also be processed at this time.

Direct deposit participants should ensure that current banking information is on file with FSA.

Important Fall Dates to Remember

New Fall Acreage Reporting Deadline

November 15, 2012 - Deadline to report 2013 fall seeded crops, perennial forage and apiculture. Contact your local county office to set up an appointment for fall acreage reporting.

Dates for CRP Haying and Grazing

September 30, 2012 - Last day for CRP managed grazing.

October 1, 2012 - Deadline to report the CRP acres hayed or grazed to your county FSA office. This deadline applies to both managed and emergency CRP hay/graze.

October 15, 2012 - Final date to have CRP hay bales removed from CRP fields. **November 30, 2012** - Final date for emergency CRP grazing. If emergency grazing occurs after October 1, 2012, report the acres grazed to your local FSA office by November 30, 2012.

Signup for 2011 Supplemental Revenue Assistance Payments (SURE) Program Announced

Producers can enroll in the Supplemental Revenue Assistance Payments (SURE) program for 2011 crop year losses beginning Oct. 22, 2012. Under the 2008 Farm Bill, SURE authorizes assistance to farmers and ranchers who suffered crop losses caused by natural disasters occurring through Sept. 30, 2011.

IRS Forms 1099-G and 1099-MISC Reporting Changes

In accordance with Internal Revenue Code sections 6041(a) and 6041A(a), if a producer's total calendar year payments are less than \$600, IRS Forms 1099-G and 1099-MISC are not required to be provided by the issuer. Beginning with 2012, FSA will not provide these forms to producers that received less than \$600 for the calendar year. Producers affected by this change should contact their tax advisor to determine if their payments are required to be reported on their tax return. Guaranteed Loan Limit Increase

Effective October 1, 2012, the maximum FSA guaranteed loan limit will increase from \$1,214,000 to \$1,302,000. This loan limit applies to guaranteed Farm Operating, Farm Ownership and Conservation loans or a combination of those types of guaranteed loans.

GovDelivery – Electronic Notice of FSA Information

The USDA Farm Service Agency offices are moving toward a paperless operation. Producers are asked to enroll in the new GovDelivery system which will provide notices, newsletters and electronic reminders instead of a hard copy through the mail.

FSA, like many other organizations, is trying to work smarter and be more efficient. Moving to electronic notifications via email will help conserve resources and save taxpayer dollars. County Committee ballots will continue to be mailed to all eligible producers.
