The Department of Homeland Security (DHS) recently announced an expanded list of science, technology, engineering and math (STEM) designated degree programs that qualify eligible graduates on student visas for an optional practical training (OPT) extension. What does this have to do with E-Verify? To be eligible for an OPT extension, STEM graduates must work for an employer enrolled in E-Verify. Learn more here.
