### SALOMON BROTHERS SERIES FUNDS INC, ET AL.

A notice has been issued giving interested persons until July 8, 1999, to request a hearing on an application filed by Salomon Brothers Series Funds Inc, et al. for an exemption from Section 17(a) of the Investment Company Act. The order would permit a series of Salomon Brothers Series Funds Inc, to acquire all of the assets and liabilities of a series of Smith Barney Investment Funds Inc.
