ENFORCEMENT PROCEEDINGS

TEMPORARY RESTRAINING ORDER ISSUED AGAINST GREAT WHITE MARINE AND RECREATION, INC. AND A. COLIN SMITH

On July 28, Judge Walter Smith, United States District Judge for the Western District of Texas, granted the Commission's request for emergency action and issued a Temporary Restraining Order halting the fraudulent activities of Great White Marine and Recreation, Inc. (Great White) and its president and chief executive officer A. Colin Smith (Smith). The Court also ordered that Smith and Relief Defendant Kenneth Ursrey provide an accounting of all investor monies received; that Great White and Smith effect no transactions in Great White or any other company's securities; and that the company make no expenditure or transfer of funds except as reasonably necessary for the operation of the company. Smith will also not participate in management of Great White, pending the Court's consideration of the Commission's motion for preliminary injunction.

According to the Commission's complaint, Great White, in a scheme devised and effectuated by Smith, engaged in a massive unregistered

distribution of 14 million Great White shares for which the company received approximately \$11 million. From these monies, Smith misappropriated approximately \$3.5 million for his own personal benefit. In connection with its unregistered distribution, Great White, in a Form 10SB registration statement filed with the Commission, and in various press releases, promotional brochures and postings to the company's internet website, made false and misleading statements concerning its financial condition and business prospects; purported audits of the company's financial statements; the sales of and the number of Great White shares issued and outstanding; and the background of its officers, directors and principal management.

In its complaint, the Commission alleges that defendants violated Sections 5(a) and (c) and 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder. The Commission also seeks an order permanently enjoining Great White and Smith, an order requiring disgorgement of all wrongfully obtained profits, with prejudgment interest, and civil penalties. The Court has set for hearing on August 23, 1999 the Commission's request for a Preliminary Injunction.

Simultaneously with the filing of its civil lawsuit, the Commission also instituted a public administrative proceeding against Great White pursuant to Section 12(j) of the Exchange Act. In the administrative proceeding, the Commission seeks to revoke Great White's securities registration. The administrative proceeding is based on the conduct identified above. [SEC v. INVESTMENT COMPANY ACT RELEASES

INTERNET CAPITAL GROUP, INC.

A notice has been issued giving interested persons until August 20, 1999, to request a hearing on an application filed by Internet Capital Group, Inc. for an order under Section 3(b)(2) of the Investment Company Act declaring applicant to be primarily engaged in a business other than that of investing, reinvesting, owning, holding or trading in securities. THE EQUITABLE LIFE ASSURANCE SOCIETY OF THE UNITED STATES, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act amending a prior order of the Commission under Section 6(c) of the Act which granted exemptions to The Equitable Life Assurance Society of the United States (Equitable Life), The Equitable of Colorado, Inc. (EOC), Separate Account No. 45 of Equitable Life, Separate Account No. 49 of Equitable Life, Separate Account VA of EOC, any other separate account established by

Equitable Life or EOC in the future to support certain deferred variable annuity contracts, EQ Financial Consultants, Inc., and Equitable Distributors, Inc. from the provisions of Sections 2(a)(32), 22(c), and 27(i)(2)(A) of the Act and Rule 22c-1 thereunder. The prior order permits, under specified circumstances, the recapture of credits equal to 3% of contributions made under certain deferred variable annuity contracts. The exemptive order amends the prior order to permit the recapture of credits of up to 5% of contributions made under the contracts. (Rel. IC-23924 - July 28)

EVERGREEN EQUITY TRUST, ET AL.

An order has been issued on an application filed by Evergreen Equity Trust, et al. granting an exemption from Section 17(a) of the Investment Company Act. The order permits certain series of registered open-end management investment companies to acquire all of the assets and assume all of the liabilities of certain other series of the investment companies. PROPOSED RULE CHANGES

The <u>National Securities Clearing Corporation</u> filed a proposed rule change (SR-NSCC-99-07) under Section 19(b)(1) of the Exchange Act. Under the proposed rule change, NSCC will amend its rules to limit its liability with respect to obligations to any affiliated entity. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 2, 1999. (Rel. 34-41662)

The <u>Depository Trust Company</u> filed a proposed rule change (SR-DTC-99-11) under Section 19(b)(1) of the Exchange Act. Under the proposed rule change, DTC will amend its rules to limit its liability with respect to obligations to any affiliated entity. In addition, DTC will amend its rules to provide that it may increase required participants fund deposits if necessary to cover costs associated with a voluntary liquidation of DTC. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 2, 1999. (Rel. 34-41663)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change (SR-BSE-99-10) submitted under Rule 19b-4 by the <u>Boston Stock Exchange</u> to amend the rules relating to the minimum variation for Nasdaq-100 Shares and disclaimer of liability with respect to the Nasdaq-100 Index. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 2, 1999. (Rel. 34-41664)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-NASD-99-31) filed by the <u>National Association of Securities Dealers</u> relating to the Automated Confirmation and Transaction Service Desk has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934.
