# SELF REGULATORY ORGANIZATIONS

## PROPOSED RULE CHANGE

The <u>American Stock Exchange</u> filed a proposed rule change (SR-Amex-96-14) to amend Articles II, III and XII of the Exchange Constitution relating to the Board of Governors. The proposed amendments would permit the appointment of a second Vice-Chairman, allow for the inclusion of the second highest ranking Exchange executive officer on the Board, and permit certain Governors to be eligible for nomination to a third term. Publication of the notice is expected in the <u>Federal Register</u> during the week of April 29. (Rel. 34-37138)
