ENFORCEMENT PROCEEDINGS

INITIAL DECISION RELEASED IN THE MATTER OF BANK OF BOSTON CORP.

Administrative Law Judge Brenda P. Murray has ordered Bank of Boston to cease and desist from committing or causing any violations and any future violations of Section 13(a) of the Securities Exchange Act of 1934 and Rules 12b-20 and 13a-13 thereunder. Judge Murray found that the bank violated the Exchange Act and rules when it filed its Form 10-Q for the second quarter of 1989 because of overwhelming evidence that the bank knew, or should have known, when it made the filing that its financials, without explanation, were misleading, and that known trends and uncertainties in its real estate portfolio would reasonably be expected to have a material unfavorable impact on the bank's financial condition. She rejected the bank's claim that it only had forward-looking information that it was not required to disclose. The decision is appealable to the Commission. (Initial Decision Rel. 81)

DEFAULT JUDGMENT AGAINST HEINZ GREIN

The Securities and Exchange Commission announced that on December 10 the United States District Court for the Southern District of New York entered a default judgment against Heinz Grein (Grein). According to the Commission's complaint, Grein engaged in insider trading by purchasing the stock of Motel 6, L.P., and Norton Co. while in possession of material, nonpublic information concerning planned tender offers for those companies. More specifically, Grein and other defendants engaged in a scheme to purchase the stocks through offshore accounts to conceal the illegal trades. Grein tipped others who also purchased.

The default judgment permanently enjoins Grein from further violations of the antifraud provisions of the federal securities laws, specifically, Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 promulgated thereunder. The judgment also orders Grein to disgorge profits of \$2,629,556.00, plus \$1,498,369.18 in prejudgment interest, and to pay a civil penalty of \$7,888,668.00, pursuant to the Insider Trading and Securities Enforcement Act of 1988, as amended. [SEC v. Borlinghaus, et al., 95 Civ. 1520, S.D.N.Y.] (LR-14762)

INVESTMENT COMPANY ACT RELEASES

HOUSEHOLD PERSONAL PORTFOLIOS

A notice has been issued giving interested persons until January 16, 1996 to request a hearing on an application filed by Household Personal Portfolios for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. THE CARDINAL GROUP, ET AL.

A notice has been issued giving interested persons until January 17, 1996 to request a hearing on an application filed under the Investment Company Act by The Cardinal Group, et al. Applicants request an order pursuant to Section 17(b) of the Act granting relief from Section 17(a). The requested order would permit applicants to effectuate a reorganization between certain registered open-end management investment companies. (Rel. IC-21619 - December 22)

VOYAGEUR FUND MANAGERS, INC., ET AL.

A notice has been issued giving interested persons until January 16, 1996 to request a hearing on an application filed by Voyageur Fund Managers, Inc. (the Sponsor) and certain registered unit investment trusts (the Trusts) sponsored by the Sponsor for an order under Section 6(c) of the Investment Company Act. The order would grant an exemption from Sections 2(a)(32), 2(a)(35), 22(d) and 26(a)(2) and Rule 22c-1 to allow the Trusts to impose sales charges on a deferred basis and waive such deferred charges in certain cases. also would grant certain Trusts an exemption from the initial net worth requirements of Section 14(a) and from the limitations on the distribution of capital gains contained in Section 19(b) and Rule 19b-Applicants further seek relief under Section 11(a) exemption from Section 11(c) to allow certain offers of exchange involving the Trusts. Finally, Applicants seek exemptive relief under Sections 6(c) and 17(b) from Section 17(a) to allow certain terminating series of the Voyageur Equity Trust to sell portfolio securities to a new series of that Trust. APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted under Rule 19b-4 by the <u>Pacific Stock Exchange</u> (SR-PSE-95-27) to amend its minor rule plan to include certain rules on financial reporting and cooperation in Exchange investigations and to establish a charge for the late filing of periodic FOCUS Reports. The Commission approved a proposed rule change (SR-CBOE-95-51) filed by the <u>Chicago Board Options Exchange</u> on August 31, 1995 proposing to list and trade options on the CBOE Automotive Index.
