# ENFORCEMENT PROCEEDINGS

#### SETTLEMENT OFFER OF MICHAEL WOZNIAK ACCEPTED

The Commission announced the entry of an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions against Michael D. Wozniak (Wozniak) and accepting Wozniak's Offer of Settlement.

The Order contains findings that on October 29, 1993, an Order of Permanent Injunction was entered by the United States District Court for the Northern District of Illinois which permanently enjoined Wozniak from future violations of Section 17(a) of the Securities Act, Section 10(b) of the Exchange Act and Rule 10b-5 promulgated thereunder. The Order also contains findings that Wozniak willfully violated the above-mentioned federal securities laws. Wozniak consented to the issuance of the Order without admitting or denying the Commission's findings, except for the entry of an Order of Permanent Injunction, which was admitted. In its civil complaint, the Commission alleged that from at least August 1991 to July 20, 1992 Wozniak engaged in activities in which he raised at least \$640,000 from 19 investors and made material, false and misleading statements and failed to disclose material facts to these investors regarding, among other things, the use of their funds and the risks of the investments. The Commission's Order bars Wozniak from association with any broker, dealer, investment company, investment adviser or municipal securities dealer. (IA-1397)

THEODORE HOFMANN, CPA, SETTLES CIVIL INJUNCTIVE ACTION AND IS BARRED IN ADMINISTRATIVE PROCEEDINGS

The Commission announced the entry of a Final Judgment of Permanent Injunctive and Other Relief (Final Judgment) against Theodore Hofmann, CPA (Hofmann), a California resident, in <u>SEC v. The Software Toolworks, et al.</u>, C-93-3581 (FMS) (N.D. Ca. Sept. 30, 1993). The complaint alleges that Hofmann was the corporate controller of The Software Toolworks, Inc. (Toolworks), and that he, along with other Toolworks officials, knowingly or recklessly provided false financial information that was included in Toolworks' June 1990 Form 10-Q. The complaint further alleges that Hofmann and others traded Toolworks' stock while in possession of material nonpublic information regarding Toolworks' financial condition. Hofmann consented to the Final Judgment, which enjoins him from further violations of the antifraud and reporting provisions of the federal securities laws, and which orders him to disgorge an amount equal to the losses he avoided by his illegal trades. [SEC v. The Software Toolworks, Inc., USDC, ND CA, Civ. Action No. 93-3581, FMS] (LR-13921; AAE Rel. 513A)

Also issued was an Opinion and Order Pursuant To Rule 2(e) of the Commission's Rules and Practice (Order) making findings and imposing remedial sanctions against Hofmann. Hofmann consented to the Order and submitted an Offer of Settlement without admitting or denying any findings, except the finding that the Final Judgment was entered against him. Hofmann also consented to the imposition of a bar against appearing or practicing before the Commission, with the right to reapply to the Commission after three years to be permitted to resume appearing or practicing before the Commission. DEFAULT JUDGMENT ENTERED AGAINST MICHAEL SCOTT LANGHEINRICH

The Commission announced that on December 21, 1993 the Honorable Aldon J. Anderson, Senior U.S. District Judge for the District of Utah, entered an order for default judgment of permanent injunction against Michael Scott Langheinrich of Salt Lake City, Utah.

The Commission's September 27, 1993 complaint alleges violations of Section 17(a) of the Securities Act of 1933, as amended, and Section 10(b) of the Securities Exchange Act of 1934, as amended, and Rule 10b-5 promulgated thereunder.

Further, the Commission's complaint alleged that in February 1992 Langheinrich telephoned a Salt Lake City broker-dealer and mislead it into believing he was his brother, who maintained an account at this broker-dealer. Langheinrich placed an order to sell all stock in his brother's account and requested that the proceeds be forwarded to his brother's address at a time when his brother was out of town. Langheinrich then used the proceeds for his personal benefit. [SEC v. Michael Scott Langheinrich, USDC, UT, Civil Action No. 93-C-857A] (LR-13924)

#### JUNCTION FINANCIAL, ET AL. ENJOINED

The Commission announced that on December 29, 1993 in the U.S. District Court for the Southern District of Florida, permanent injunctions were entered, by consent, against Junction Financial Corporation, U.S. Ostrich Corporation, Stephen E. Tashman and Marcia Josowitz. They are enjoined from future violations of the registration, antifraud, and broker-dealer registration and antifraud provisions of the federal securities laws. The Commission's complaint in this matter alleged that the defendants raised over \$3,000,000 from approximately 1,100 investors in 48 of the United States and Ganada and converted the majority of the funds to use of the principals and others; offered and sold investment contracts which were characterized by the defendants as general partnership while no registration statement was in effect; made misstatements and omitted to state material facts concerning the use of proceeds, that cease and desist orders against further sales had been entered by several states and that Tashman failed to disclose a felony conviction; and that these interests were sold by the defendants while the defendants were not registered with the Commission as broker-dealers. The amount of disgorgement, prejudgment interest and civil penalties are to be determined by the Court at a later date. SEC V. Junction Financial Corporation, U.S. Ostrich Corporation, Stephen E. Tashman and Marcia Josowitz, Civil Action No. 93-7082, USDC, SD FL] (LR-13926)

#### TERENCE ZAWACKI SENTENCED

The Commission announced that on September 21, 1993 the U.S. Attorney for the Northern District of Ohio accepted a guilty plea from Terence W. Zawacki (Zawacki) in response to an 18-count information previously filed against him. Zawacki was the president of First Ohio Securities Company (FOSC), a now defunct broker-dealer previously registered with the Commission. He pled guilty to, among other things, violations of Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 promulgated thereunder, in connection with his involvement in the unlawful conversion of funds from customers of FOSC. Zawacki was sentenced to 33 months imprisonment, three years probation, and ordered to pay restitution of approximately \$3 million and to perform 3,000 hours of community service.

On December 4, 1992, the Commission filed a complaint charging Zawacki with violations of the federal securities laws based on the same conduct underlying the criminal information. Thereafter, on June 10, 1993, the Commission obtained an Order of Permanent Injunction against Zawacki, pursuant to his consent and without him admitting or denying the allegations of the Commission's complaint. [U.S. v. Terence W. Zawacki, N.D. Oh., No. 5:93CR191] (LR-13927)

### NEVADA MANHATTAN MINING SALESPERSON ENJOINED

The Commission announced that on December 22, 1993 a judgment of permanent injunction was entered against Freya Sortomme Kovarik (Kovarik), a former salesperson for the California-based mining company, Nevada Manhattan Mining, Incorporated (NMM). The judgment provides that Kovarik is enjoined from future violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. Kovarik consented to the entry of the injunction against her without admitting or denying the facts alleged in the Commission's complaint. The Commission filed a complaint against NMM, its officers and several of its salespersons, including Kovarik, on July 28, 1993. The Commission's complaint alleged that from the Spring of 1988 through the Summer of 1989, Kovarik, while acting as an unregistered broker, fraudulently offered and sold unregistered stock in NMM. All other defendants in this action previously settled with the Commission. [SEC v. Nevada Manhattan Mining, Incorporated, et al., Civil Action No. 93-4468 MRP, JGx, C.D. Cal.] (LR-13928)

#### INVESTMENT COMPANY ACT RELEASES

PIC INVESTMENT TRUST, ET AL.

A notice has been issued giving interested persons until February 1, 1994 to request a hearing on an application filed by PIC Investment Trust, et al. for a conditional order under Section 6(c) of the Investment Company Act exempting applicants from Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order would permit certain investment companies to assess a contingent deferred sales charge (CDSC) on certain redemptions of shares and waive the CDSC under certain circumstances. (Rel. IC-20006 - January 7)

GRADISON U.S. GOVERNMENT TRUST

A notice has been issued giving interested persons until February 4, 1994 to request a hearing on an application filed by Gradison U.S. Government Trust for an order pursuant to Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-20007 - January 10)

#### HOLDING COMPANY ACT RELEASES

#### GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until January 31 to request a hearing on a proposal by General Public Utilities Corporation (GPU), a registered holding company, to make capital contributions to its operating subsidiary companies in aggregate amounts of up to \$200 million, through December 31, 1996. (Rel. 35-25971)

NEW ENGLAND ELECTRIC SYSTEM, ET AL.

A supplemental notice has been issued giving interested persons until January 31 to request a hearing on a proposal by New England Electric System (NEES), a registered holding company, and New England Electric Resources, Inc. (NEERI), its nonutility subsidiary company. NEERI seeks authorization through December 31, 1997 to expand its consulting services to nonaffiliates at market rates to include the performance of electrical related services. NEES proposes, from time to time through December 31, 1997, to make additional capital contributions of up to \$1 million for NEERI. (Rel. 35-25971)

#### CONSOLIDATED NATURAL GAS COMPANY ET AL.

A notice has been issued giving interested persons until January 24 to request a hearing on a proposal by Consolidated Natural Gas Company (CNG), a registered holding company, and its wholly owned subsidiary company CNG Energy Company (Energy), to engage in preliminary development and administrative activities with respect to qualifying small power production facilities, exempt wholesale generators and foreign utility companies (collectively, Preliminary Activities). CNG further proposes to provide Energy, through December 31, 1998, up to an aggregate principal amount of \$15 million to engage in Preliminary Activities. (Rel. 35-25971)

#### JERSEY CENTRAL POWER & LIGHT COMPANY

A notice has been issued giving interested persons until January 31 to request a hearing on a proposal by Jersey Central Power & Light Company, an electric publicutility subsidiary company of General Public Utilities Corporation, a registered holding company, to deliver letters of credit that will expire no later than December 31, 1998, in aggregate face amounts not exceeding \$15 million. (Rel. 35-25971)

#### GENERAL PUBLIC UTILITIES CORP., ET AL.

A notice has been issued giving interested persons until January 31 to request a hearing on a proposal by General Public Utilities Corporation (GPU), a registered holding company, and its wholly owned non-utility subsidiary company, Energy Initiatives, Inc. (EII). EII proposes to acquire a limited partnership interest for \$11.5 million in a Canadian limited partnership being formed to develop, construct, own, and operate a 22.5 megawatt wood and oil fired cogeneration facility in Brooklyn, Nova Scotia, Canada. EII proposes to secure its equity contribution to the limited partnership through an irrevocable letter of credit for \$11.5 million with GPU unconditionally guaranteeing EII's obligations. Alternatively, should the limited partnership elect to borrow \$11.5 million from lending institutions to provide a portion of the construction financing, GPU proposes to guarantee unconditionally EII's repayment obligations. # AMERICAN ELECTRIC POWER CO., INC., ET AL.

A notice has been issued giving interested persons until January 31 to request a hearing on a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, and its nonutility subsidiary company, AEP Energy Services, Inc. (AEP Energy), for AEP to make additional investments in AEP Energy, through December 31, 1995, in the amount of \$5 million for preliminary development activities associated with its consulting business. AEP and AEP Energy also propose to expand the current scope of financial commitment of AEP to include the issuance of guarantees or assumption of liabilities by AEP on behalf of AEP Energy to unaffiliated third parties in an aggregate amount not to exceed \$25 million.
