ENFORCEMENT PROCEEDINGS

PERMANENT INJUNCTIONS ENTERED AGAINST GREAT WESTERN COMMUNICATIONS INT'L. AND ROBERT SEIBERT

The Commission announced that on December 21, 1993 the Honorable William C. O'Kelley, Chief United States District Judge for the Northern District of Georgia, entered orders of Permanent Injunction and Other Relief against defendants Great Western Communications Int'l. (Great Western) and Robert Seibert (Seibert), both of Newport Beach, California. The defendants consented to the entry of the permanent injunctions without admitting or denying the allegations contained in the Commission's complaint.

The Commission's complaint, filed on September 30, 1993, alleged fraud in the offer and sale of securities in the form of interests in the Gulf Partners General Partnership, purportedly formed for the purpose of owning and operating a wireless cable television system in Ocala, Florida. The Commission alleged that Great Western, under the control of Seibert, solicited investments in the partnership since at least April 1993, by interstate telephone solicitations and follow-up mailings of offering documents. The Commission alleged that Great Western and Seibert fraudulently misrepresented the number of wireless cable channels it had acquired in the Ocala area. Also, the Commission alleged that the proceeds of the offering were being spent for purposes undisclosed to investors. The Court's orders continued a freeze on any funds derived from the sale of interests in the partnership. The Commission's claims for disgorgement of the ill-gotten gains and civil penalties against Great Western and Seibert remain unresolved. [SEC v. Mitchell Communications Corp. et al., USDC, NDGA, Civil No, 1:93-CV-2226-WCO] (LR-13950)

INVESTMENT COMPANY ACT RELEASES

THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, ET AL.

A notice has been issued giving interested persons until February 22, 1994 to request a hearing on an application filed by The Prudential Insurance Company of America (Prudential), Pruco Life Insurance Company, Pruco Life Insurance Company of New Jersey, The Prudential Variable Appreciable Account, The Pruco Life Variable Appreciable Account, The Pruco Life Variable Universal Account, The Pruco Life PRUvider Variable Appreciable Account, and The Pruco Life of New Jersey Variable

Appreciable Account for an order under Section 6(c) of the Investment Company Act for exemptions from Sections 27(c)(2) and paragraph (c)(4)(v) of Rule 6e-3(T) under the Act. Applicants request relief to the extent necessary to permit them to impose a premium based charge under certain flexible premium variable life insurance policies in an amount that is reasonably related to Prudential's increased federal income tax burden resulting from the application of Section 848 of the Internal Revenue Code of 1986, as amended. (Rel. IC-20033 - January 25)

CONNECTICUT LIQUIDITY INVESTMENT FUND, INC.

A notice has been issued giving interested persons until February 22, 1994 to request a hearing on an application filed by Connecticut Liquidity Investment Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. HOLDING COMPANY ACT RELEASES

MAINE YANKEE ATOMIC POWER COMPANY

A supplemental order has been issued correcting the Commission's order dated January 12, 1994 (HCAR No. 25973) authorizing Maine Yankee Atomic Power Company, an indirect nuclear generating subsidiary company of Northeast Utilities and New England Electric System, registered holding companies, to issue and sell its short-term notes and commercial paper in outstanding aggregate principal amounts of up to \$21 million, through December 31, 1996. (Rel. 35-25981)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved proposed rule changes filed by the Midwest Clearing Corporation and Stock Clearing Corporation of Philadelphia (SR-MCC-93-04 and SR-SCCP-93-03) relating to the establishment of interfaces with the National Securities Clearing Corporation's Fixed Income Transaction System. (Rel. 34-33524)

The Commission approved a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-93-11) that permits NSCC to revise its net capital requirements and its clearing fund requirements for entities that use only NSCC's mutual fund services. (Rel. 34-33525)

PROPOSED RULE CHANGE

The New York Stock Exchange filed a proposed rule change (SR-NYSE-93-49) to revise its bond listing standards. Publication of the proposal is expected in the Federal Register during the week of January 31. (Rel. 34-33531)
