# ENFORCEMENT PROCEEDINGS

### SHLOMO SELA BARRED

The Commission announced the entry of an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions against Shlomo Sela (Sela), and accepting Sela's Offer of Settlement. Sela consented to the issuance of the Order without admitting or denying the Commission's findings.

The Order contains findings that in 1987, Sela, as a registered representative at PaineWebber, Inc., engaged in unsuitable trading in his customers' accounts by employing a risky options strategy and also engaged in excessive trading in these accounts. In connection with these trades, Sela made misrepresentations and omissions of material facts to customers about the value of their accounts and the risks associated with Sela's trading strategy. In addition, Sela aided and abetted books and records violations by falsifying information on new account forms and option qualification forms. The Order also contains findings that on March 4, 1994, an Order of Permanent Injunction was entered by the U.S. District Court for the Southern District of Texas which permanently enjoined Sela from future violations of the same federal securities laws. The Commission's Order permanently bars Sela from associating with any regulated entity. (Rel. 34-33789)

FINAL JUDGMENT ENTERED AGAINST DAVID ZUCKERMAN AND Q CONSULTING, INC. FOR FRAUD INVOLVING PRIME BANK SECURITIES

The Commission announced that on March 7 the Honorable Sim Lake, United States District Judge for the Southern District of Texas, entered a Final Judgment of Permanent Injunction and Other Equitable Relief against David Stuart Zuckerman and Q Consulting, Inc. of Marina del Ray, California permanently enjoining them from violating the antifraud and registration provisions of the federal securities laws. The order requires defendants to disgorge \$1,121,000.06, pay prejudgment interest of \$128,220.08, and pay a civil fine of \$550,000. The complaint filed in August 1992 alleged that from March 1991 to March 1992 defendants made numerous misrepresentations and omissions of material fact in the offer and sale of unregistered securities. Among other things, defendants falsely represented that they would provide a return

to investors of 46 to 48% by leveraging pooled investor funds to invest in debt instruments of "prime world banks." The complaint also alleged that Zuckerman falsely claimed to be an attorney and trustee of a Zuckerman Family Trust valued at over \$600 million and that he misappropriated at least \$1 million of investor funds. # THE WOODWARD FUNDS, ET AL.

A notice has been issued giving interested persons until April 18 to request a hearing on an application filed by The Woodward Funds, et al. for a conditional order under Sections 6(c), 17(b), and 17(d) of the Investment Company Act and Rule 17d-1 thereunder. The order would exempt applicants from Sections 12(d)(1)(A) and 17(a) and permitting certain joint arrangements pursuant to Section 17(d) and Rule 17d-1. The order would also permit certain series of the Woodward Funds to purchase the shares of money market series in the same investment company. (Rel. IC-20159 - March 24)
