ENFORCEMENT PROCEEDINGS

EDWARD ACCOMANDO BARRED

The Commission instituted administrative proceedings pursuant to Sections 15(b) and 19(h) of the Exchange Act against Edward A. Accomando (Accomando), a former registered representative with First Albany Corporation, a registered broker-dealer. The Order, based on Accomando's Offer of Settlement, bars Accomando from association with any broker, dealer, municipal securities dealer, investment adviser or investment company, with a right to reapply after three years.

Accomando was permanently enjoined from violating the antifraud and credit extension provisions of the federal securities laws. The complaint alleged that Accomando manipulated the stock of Central Co-Operative Bank by executing 64 Central cross trades in his customers' accounts in a twelve-month period. He also allegedly aided and abetted the improper extension of credit to customers for the purpose of purchasing or carrying securities. Accomando's former employer, First Albany Corporation, and two of its executives were previously sanctioned by the Commission for failing to supervise Accomando's trading activity. (Rel. 34-33885)

TRO ENTERED AGAINST CENTURION GROWTH FUND, INC.

The Commission announced that on April 12 the Honorable Ursula Ungaro-Benages, United States District Judge, granted the Commission's request for a temporary restraining order against Centurion Growth Fund, Inc. (Fund). The Order temporarily restrains and enjoins the Fund from violations of the disclosure requirements of the Securities Act of 1933 and the disclosure and reporting provisions of the Investment Company Act of 1940, freezes the assets of the Fund, prohibits the destruction of the Fund's books and records, appoints a receiver for the Fund and suspends the offer, sale and redemption of the Fund's shares until further order of the Court.

The complaint alleged that since December 1993 the management of the Fund had become increasingly deadlocked and in disarray and since April 1, 1994, the Fund has not had a properly constituted board of directors. As a result, the Fund is delinquent in its filings with the Commission and has not fulfilled its disclosure obligations to its shareholders. [SEC v. INVESTMENT COMPANY ACT RELEASES

UNITED OF OMAHA LIFE INSURANCE COMPANY, ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting United of Omaha Life Insurance Company, United of Omaha Separate Account B (Account B) and Mutual of Omaha Investor Services, Inc. from the provisions of Sections 26(a)(2) and 27(c)(2) of the Act to the extent necessary to permit the deduction of mortality and expense risks charges from the assets of Account B in connection with the offer and sale of certain group flexible payment variable deferred annuity contracts.
