INVESTMENT COMPANY ACT RELEASES

SIT MUTUAL FUNDS, INC., ET AL.

An order has been issued on an application filed by SIT Mutual Funds, Inc., et al. under Section 6(c) of the Investment Company Act granting an exemption from Section 12(d)(1)(A)(ii), under Sections 6(c) and 17(b) granting an exemption from Section 17(a), and under Rule 17d-1 permitting certain joint transactions in accordance with Section 17(d) and Rule 17d-1. The order permits certain money market funds to sell their shares to affiliated investment companies. (Rel. IC-20482 - August 16)

THE FIRST TRUST SPECIAL SITUATIONS TRUST, ET AL.

An order has been issued on an application filed by The First Trust Special Situations Trust and Nike Securities, L.P. under Sections 11(a) and 11(c) of the Investment Company Act permitting certain offers of exchange of units of a terminating Trust series for units of subsequently offered Trust series. (Rel. IC-20483 - August 16)

BERLINER HANDELS - UND FRANKFURTER BANK

An order has been issued on an application filed by Berliner Handels - und Frankfurter Bank (BHF-Bank) under Section 6(c) of the Investment Company Act for an exemption from Section 17(f). The order permits registered management investment companies for which BHF-Bank or Zivnostenska Banka acts as foreign custodian or subcustodian (other than investment companies registered under Section 7(d)) to maintain their foreign securities and other assets in the custody of Zivnostenska Banka in the Czech Republic. (Rel. IC-20484; International Series Rel. 700 - August 16)

ALEX. BROWN CASH RESERVE FUND, INC., ET AL.

A notice has been issued giving interested persons until September 12 to request a hearing on an application filed by Alex. Brown Cash Reserve Fund, Inc., et al. for an exemption under Section 6(c) of the Investment Company Act from Sections 13(a)(2), 13(a)(3), 17(a)(1), 18(f)(1), 22(f), and 22(g) and Rule 2a-7 thereunder, and under Section 17(d) and Rule 17d-1 thereunder. Applicants request an order to permit certain investment companies to enter into deferred compensation arrangements with their independent directors. (Rel. IC-20489 - August 18)

HOLDING COMPANY ACT RELEASES

METROPOLITAN EDISON COMPANY

A supplemental order has been issued authorizing the underwriting fees and expenses and the distribution rate associated with the issuance and sale of \$100 million stated value of preferred limited partnership interests, in the form of Monthly Income Preferred Securities, \$25 per security stated value (MIPS), by Met-Ed Capital, L.P. (Met-Ed Capital), a special purpose limited partnership subsidiary of Metropolitan Edison Company, a public-utility subsidiary company of General Public Utilities Corporation, a registered holding company. The issuance and sale of the MIPS and related transactions were authorized by the Commission on August 11, 1994 (HCAR No. 26102). (Rel. 35-26105)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the Chicago Stock Exchange (SR-CHX-94-07) relating to utilization of exempt credit by market makers. (Rel. 34-34538)

The Commission approved a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-94-16) to adopt audit trail account identification codes for transactions that are exempt from the short sale rules. (Rel. 34-34539)

PROPOSED RULE CHANGES

The Philadelphia Depository Trust Company filed a proposed rule change (SR-Philadep-94-04) that amends Philadep Rule 2, Section 1 to require each participant and pledgee to execute a Participant's Agreement. Publication of the proposal is expected in the Federal Register during the week of August 22. (Rel. 34-34540)

The Municipal Securities Rulemaking Board filed a proposed rule change (SR-MSRB-94-10) to define "regular way" settlement of municipal securities as three business days. Publication is expected in the Federal Register during the week of August 22. (Rel. 34-34541)

CORRECTION TO CIVIL ACTION RELEASE AGAINST RICHARD ADLER, ET AL.

An error was made in yesterday's announcement of the Commission's civil action against Richard F. Adler, et al. The complaint filed in this action alleges that Domer L. Ishler made a profit of \$368,000 in transactions involving the purchase of Comptronix put options. The announcement misstated this amount as \$268,000.
