DIVISION OF CORPORATION FINANCE ANNOUNCES TERMINATION DATE FOR EARLY REVIEW PROXY PROGRAM

With the conclusion of the 1994 proxy season, the Division of Corporation Finance has established September 2, 1994 as the last day for submitting draft executive compensation disclosure for review prior to filing with the Commission. Until that date, drafts may continue to be submitted to the attention of John Bernas of the Division of Corporation Finance by facsimile to (202) 272-7546 or by mail to the Securities and Exchange Commission, 450 Fifth Street, N.W., Washington, D.C. 20549, mail stop 3-4. Issuers submitting the information on EDGAR should use the document tag <CORRESP> to ensure that the information remains non-public. ENFORCEMENT PROCEEDINGS

TEMPORARY RESTRAINING ORDER ENTERED AGAINST KEY WEST WIRELESS PARTNERS, ET AL.

The Commission announced that on August 16 a complaint was filed in, and a Temporary Restraining Order was entered by, the U.S. District Court for the Southern District of Ohio against Key West Wireless Partners, Lancaster Broadcasting Partners, Universal Funding Corporation, Gerald Wireless Cable Corporation, Strathmore & Associates, Inc., Raymond P. O'Connor and Associates, Inc., Satellite Microcable Corporation, Keys Microcable, Microcable, Florida Inc., Lancaster Broadcasting Entertainment, Hubbell Communications, Inc., Michael Eberle, Gerald Seifer, Raymond P. O'Connor, Donald Gilliland, Robert Geiss, A. Dan Horn and J. Kelly Bloomer, enjoining the defendants from future violations of registration and antifraud provisions of the federal securities laws, freezing assets, prohibiting transfer of funds and destruction of documents, and ordering an accounting.

The complaint alleges that, since April 1993, the defendants have fraudulently sold unregistered securities in the form of partnership interests, raising approximately \$4.6 million for Key West Wireless and approximately \$1.3 million for Lancaster Broadcasting from 487 investors in 40 states. According to the complaint, the defendants fraudulently misrepresented that they had the rights to sufficient FCC licenses to construct a 30 channel wireless cable TV system in the Florida Keys, when, in reality, no such licenses exist. The complaint further alleges that the defendants fraudulently misrepresented the returns and the risks associated with the investments and failed to disclose securities and trade practice fraud injunctions against several of the defendants. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES AND AMENDMENTS TO PROPOSED RULE CHANGES

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-94-19) and on August 18, 1994, the CBOE filed Amendment No. 1 to the proposed rule change, relating to listing and trading options on the CBOE Emerging Markets Index. Publication of the notice is expected in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34552; International Series Rel. 703)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-94-20) and on August 18, 1994, the CBOE filed Amendment No. 1 to the proposed rule change, relating to listing and trading options on the CBOE Emerging Asian Markets Index. Publication of the notice is expected in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34553; International Series Rel. 701)

The American Stock Exchange filed a proposed rule change (SR-Amex-94-18) to list and trade options on the Israel Index (Index), a narrow-based, "modified" equal dollar weighted index comprised of eleven Israeli and American Depositary Receipts traded on the New York Stock Exchange, Amex or that are National Market Securities traded through the National Association of Securities Dealers Automated Quotation system. The original proposal was superseded by Amendment No. 1, which was filed with the Commission on August 2, 1994. On August 8, 1994, the Exchange filed Amendment No. 2 to the proposal to clarify how the Index will be weighted when the number of Index components changes from eleven. Publication of the notice is expected in the Federal Register during the week of August 22. (Rel. 34-34554)

The <u>Cincinnati Stock Exchange</u> filed Amendment No. 1 to a proposed rule change (SR-CSE-94-01) to amend the ITS inbound execution requirement in the Quality of Markets Policy. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34555)

PROPOSED RULE CHANGES

The <u>Boston Stock Exchange</u> filed a proposed rule change (SR-BSE-94-07) to require that all broker-dealers assigned to the Exchange as their Designated Examining Authority provide the Exchange with reports of all outside assets and liabilities attributable to the broker-dealer. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34556)

The Philadelphia Stock Exchange filed a proposal (SR-PHLX-94-36) to amend Section 9-1 of Article IX of the Exchange's By-Laws to allow two members of the PHLX's Board of Governors, rather than two Vice Chairmen, to serve as trustees of the PHLX's Stock Exchange Fund and to allow qualified non-members to serve as trustees. The PHLX also proposes to amend Section 10-13 of Article X of the PHLX's By-Laws to delete the requirement that the PHLX's Executive Vice President serve on the PHLX's Executive Committee. Publication of the notice is expected in the Federal Register during the week of August 22. (Rel. 34-34567)

The Depository Trust Company filed proposed rule changes (SR-DTC-94-08 and SR-DTC-94-09) relating to procedures to recall certain deliveries of securities which have created short positions. Publication of the proposals is expected in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34561)

The Philadelphia Depository Trust Company and the Stock Clearing Corporation of Philadelphia filed proposed rule changes (SR-Philadep-94-02 and SR-SCCP-94-04) to amend existing Philadep and SCCP rules to further define the standard of care with respect to custodial and noncustodial functions; add provisions limiting suits against Philadep and SCCP directors, officers, and employees; and add provisions that require a participant, in certain circumstances, to pay the expenses and outside attorneys' fees incurred by Philadep and SCCP in defending a legal proceeding instituted by such participant. (Rel. 34-34560)

The <u>Boston Stock Exchange</u> filed a proposed rule change (SR-BSE-94-09) relating to stopping stock. Publication of the proposal is expected in the Federal Register during the week of August 22. (Rel. 34-34569)

The <u>Pacific Stock Exchange</u> filed a proposed rule change (SR-PSE-94-19) to amend PSE Rule 6.86, "Trading Crowd Firm Disseminated Market Quotes," to increase the minimum size guarantee for non-broker/dealer customer orders from 10 option contracts to 20 contracts. Publication of the notice is expected in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34571)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-94-39) to institute a security application fee for The PORTAL Market. (Rel. 34-34562)

The Commission approved a proposed rule change (SR-CBOE-94-02) filed by the Chicago Board Options Exchange, which imposes fees and suspensions on market makers who fail to observe certain participation duties on the Retail Automated Execution System (RAES) for equity and Standard & Poor's 500 Index (SPX) classes of options. Among other things, the CBOE's proposal amends CBOE Rules 8.16, "RAES Eligibility in Equity Options," and 24.16, "RAES Eligibility in SPX/NDX," to impose the following fees for failures to satisfy the rules' log-off requirements: a fee of \$100.00 for each of one to three failures within one twelvemonth period; a fee of \$250.00 for each of four to six failures Within one twelve-month period; and a fee of \$500.00 for each of seven or more failures within one twelve-month period. In addition, the CBOE will Regulatory Circular clarifying market makers' a responsibilities with respect to equity and SPX options classes. Publication of the approval order is expected to appear in the Federal Register during the week of August 22. (Rel. 34-34565)

The Commission approved a proposed rule change submitted by the <u>New York Stock Exchange</u> (SR-NYSE-94-09) to amend Rule 321 to clarify the term "control" and amend Rules 113, 122 and 321 to delete the word affiliate and insert the word "subsidiary". (Rel. 34-34566)

The Commission approved the proposed rule change (SR-NASD-94-27) filed by the <u>National Association of Securities Dealers</u> that amends the customer record retention requirements for options accounts applicable to supervisory offices as set forth in Sections 33(b)(17) and (20) of the NASD Rules of Fair Practice. (Rel. 34-34564)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the <u>Chicago Stock Exchange</u> (SR-CHX-94-15) relating to corporate governance issues. (Rel. 34-34563)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Option Clearing Corporation filed a proposed rule change (SR-OCC-94-09) relating to Canadian depository participation in the on-line Escrow Receipt Depository system. The rule change was effective upon filing. Publication of the notice is expected in the Federal Register during the week of August 22. (Rel. 34-34568)

A proposed rule change (SR-PSE-94-20) filed by the <u>Pacific Stock Exchange</u>, which amends the PSE's rate for services on its options floor, including certain transactions charges, floor and market maker charges, and charges for certain transactions on the Pacific Options Exchange Trading System, has become effective upon filing. Publication of the order is expected in the <u>Federal Register</u> during the week of August 22. (Rel. 34-34570)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE AND AMENDMENT TO PROPOSED RULE CHANGE

The Commission has granted accelerated approval of a proposed rule change (SR-Amex-94-17) and Amendment No. 1 to the proposed rule change filed by the American Stock Exchange relating to the dissemination of the value of the basket underlying stock upside note securities (SUNS). Publication of the notice and approval order is expected in the Federal Register during the week of (Rel. 34-34572)

ACCELERATED APPROVAL ON A TEMPORARY BASIS OF A PROPOSED RULE CHANGE

The Commission approved on an accelerated and temporary basis a proposed rule change (SR-NSCC-94-17) submitted by the <u>National Securities</u> <u>Clearing Corporation</u>. The proposal authorizes NSCC to use intrabank transfers of funds for settlement obligations through August 31, 1995. (Rel. 34-34573)
