INVESTMENT COMPANY ACT RELEASES

THE STANDARD BANK OF SOUTH AFRICA, LTD.

Notices have been issued giving interested persons until October 31 to request a hearing on applications filed by The Standard Bank of South Africa, Ltd. An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Chubb Life Insurance Company of America (Chubb Life), Chubb Separate Account VA-1 (Chubb Separate Account), The Colonial Life Insurance Company of America (Colonial Life), Colonial Separate Account VA-2 (Colonial Separate Account), and Chubb Securities Corporation from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order provides exemptions to the extent necessary to permit the deduction of mortality risk charges and expense risk charges from the assets of the Chubb Separate Account and the Colonial Separate Account under certain individual flexible payment deferred variable annuity contracts issued by Chubb Life and Colonial Life, respectively. FIRST ING LIFE INSURANCE COMPANY OF NEW YORK, ET AL.

A notice has been issued giving interested persons until October 31 to request a hearing on an application filed by First ING Life Insurance Company of New York (First ING Life), First ING of New York Separate Account Al (Separate Account), certain future separate accounts that may be created by First ING Life, and SLD Equities, Inc. for an order that would permit Applicants to deduct a mortality and expense risk charge from the assets of the Separate Account and the future separate accounts. INDIANA MICHIGAN POWER COMPANY

A supplemental order has been issued authorizing Indiana Michigan Power Company, an electric utility subsidiary of American Electric Power Company, Inc., a registered holding company, to effect the refunding of up to \$50 million of pollution control revenue bonds issued in connection with the financing of pollution control facilities. AMERICAN ELECTRIC POWER CO., INC., ET AL.

A supplemental order has been issued authorizing a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, and AEP Generating Company (Generating), an electric public-utility subsidiary of AEP. AEP and Generating propose that Generating enter into an agreement with the City of Rockport, Indiana to issue up to \$55 million of a series of refunding bonds (Refunding Bonds) the proceeds of which will be used to redeem \$55 million principal amount of City of Rockport, Indiana, Fixed Rate Pollution Control Revenue

Bonds, 9-3/8% Series 1985 A Bonds maturing on September 1, 2014; Generating provide some form of credit enhancement for the Refunding Bonds, such as a letter of credit, surety bonds or bond insurance, and pay a fee in connection therewith; and AEP provide a guaranty for the payment of principal and interest on the Refunding Bonds in order to provide credit enhancement for the Refunding Bonds in the alternative to, or as a supplement to, the letter of credit, surety bonds or bond insurance that Generating may acquire or issue. CINERGY CORP.
