ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST GERALD UNTERMAN

The Commission announced today the institution of administrative proceedings pursuant to Sections 203(e), 203(f) and 203(k) of the Investment Advisers Act of 1940 and the entry of an Order making findings that Gerald B. Unterman, an officer, director and minority shareholder of Solomon Asset Management, Inc. (SAM), a registered investment adviser that is now known as Cypress Capital Management, Inc., willfully, as used in Sections 203(e) and 203(f) of the Advisers Act, aided and abetted and was a cause of SAM's violations of Sections 206(1) and 206(2) of the Advisers Act. The Order also requires Unterman to cease and desist from causing any violation and any future violation of Sections 206(1) and 206(2) of the Advisers Act; censured him; and requires Unterman to cause three investment advisers to maintain internal procedures, policies and controls which are reasonably designed to assure compliance with the federal securities laws as long as he is associated with one or more of these Investment Advisers. The Commission simultaneously accepted Unterman's consent to issuance of the Order.

The proceedings against Unterman arise out of an agreement between David B. Solomon and Michael R. Milken involving transactions effected for the accounts of SAM clients. (Rel. IA-1448)

COMPLAINT FILED AGAINST J. PATRICK KERICH

On September 30, the Commission filed a complaint in the U.S. District Court for the District of Columbia against J. Patrick Kerich (Kerich), former Chief Executive Officer and Chairman of the Board of Mallard Coach Co., Inc. (Mallard), alleging violations of the antifraud and reporting company provisions of the federal securities laws. Simultaneous with the filing of the complaint Kerich submitted a Consent and Stipulation in which he, without admitting or denying the allegations of the Commissions complaint, consented to the relief requested. Accordingly, on October 4, 1994, the Court entered an order enjoining Kerich from future violations of the above cited provisions and ordering Kerich to pay a \$50,000 civil penalty. The Commissions complaint had alleged that during Mallards fiscal year 1991 Kerich, among other things, caused numerous unsupported adjustments to Mallards financial statements filed with the Commission which had the effect of understating losses and, thereby, overstating income. INVESTMENT COMPANY ACT RELEASES

GREAT HALL INVESTMENT FUNDS, INC., ET AL.

A notice has been issued giving interested persons until November 14 to request a hearing on an application filed by Great Hall Investment Funds, Inc., et al. for an order under Section 6(c) of the Investment Company Act that would exempt certain investment companies from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The requested order would permit the investment companies to offer an unlimited number of classes of shares representing interests in the same portfolio of securities, and to assess and, under certain circumstances, waive a contingent deferred sales charge. STADSHYPOTEK AB

A notice has been issued giving interested persons until November 7 to request a hearing on an application filed by Stadshypotek AB under Section 6(c) of the Investment Company Act for an order exempting applicant from all provisions of the Act. Applicant is a wholly-owned subsidiary of Konungariket Sveriges stadshypotekskassa (UMB). UMB was established by the Swedish government to finance the acquisition and development of residential and commercial properties in Sweden through mortgage lending. UMB is being converted into a private sector limited liability company. Applicant is the corporation through which this privatization will be accomplished. As part of the privatization, applicant intends to offer and sell a tranche of its common shares in the United States pursuant to Rule 144A under the Securities Act of In addition, applicant may offer and sell other debt and equity 1933. securities in the United States in the future. THE BRINSON FUNDS, ET AL.

A conditional order has been issued on an application filed by The Brinson Funds, et al. under Section 6(c) of the Investment Company Act for an exemption from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order permits certain open-end management investment companies to issue multiple classes of shares representing interests in the same investment portfolio and assess and, under certain circumstances, waive or reduce a contingent deferred sales charge on certain redemptions of shares. WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until November 8 to comment on the application of Cohu, Inc. to withdraw its Common Stock, \$1.00 Par Value, from listing and registration on the <u>American Stock</u> <u>Exchange</u>. (Rel. 34-34855)
