# COMMISSION ANNOUNCEMENTS

# SEC NEW 800 NUMBER AVAILABLE TO PUBLIC

Today the Commission initiated its first 800 number toll free information service. The service is part of a broader effort by the Commission to increase accessibility of its information resources for investors and the general public.

By dialing 1-800-SEC-0330, callers access a system based on current telephone technology that explains how to order investor protection brochures, Commission publications, information about the Commission's enforcement program and procedures for filing complaints. The service also tells how to obtain official company filings or to find out if a securities firm or employee has been the subject of disciplinary action.

Other aspects of this Commission initiative include access to Fedworld, a public electronic bulletin board operated by the Department of Commerce. The bulletin board, announced in the October 3rd issue of the Digest, carries current issues of the SEC News Digest and the texts of various informational brochures, investor columns and bulletins, speeches, testimony and selected releases concerning rule making. Anyone with a modem and communications software can connect directly with Fedworld by dialing (703) 321-8020 or via the Internet.

# CUSTOMER SERVICE PLANS OF THE SECURITIES AND EXCHANGE COMMISSION

In response to Executive Order 12862 issued as part of the Vice President's National Performance Review, the Securities and Exchange Commission (SEC) developed a customer service plan. The goal of the plan is to enhance investor protection through an improved investor education effort and a redirection of resources to augment the SEC's responsiveness to investor concerns and complaints. The plan submitted to the Vice President of September 8, was modified slightly on October 24. The modified plan is available in the SEC Public Reference Rooms.

### **ENFORCEMENT PROCEEDINGS**

## STEPHEN HOLLOWAY ENJOINED

The Commission announced that on October 13, the Honorable Nancy G. Edmunds, U.S. District Court Judge for the Eastern District of Michigan, permanently enjoined Stephen A. Holloway (Holloway), from further violations of the registration and antifraud provisions of the federal securities laws. The Court also ordered Holloway to disgorge \$119,195.03 plus prejudgment interest, but waived payment based upon his demonstrated inability to pay. Holloway consented to the entry of the order against him without admitting or denying the allegations contained in the complaint.

According to the complaint, from in or about February 1987 through June 1990, Holloway, while acting as an unregistered broker-dealer, along with associates sold approximately \$3,000,000 worth of unregistered promissory notes to numerous investors for investments in entities known as GT&T Limited Partnerships. The complaint further alleges that, in connection with the foregoing activity, Holloway made material misstatements and omissions to investors concerning, among other things, the guaranteed nature of the investments and the use of investors' funds for real estate development ventures. # INVESTMENT COMPANY ACT

# GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY

An order has been issued under Section 6(c) of the Investment Company Act exempting Great-West Life & Annuity Insurance Company (Great-West Life), Maxim Series Account (Separate Account), and The Great West Life Assurance Company from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. Applicants have been granted exemptive relief to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account in connection with the issuance of sale of certain variable annuity contracts (Contracts), and from the assets of the Separate Account, and of any other separate account established in the future by Great-West Life, in connection with the issuance of variable annuity contracts that are substantially similar in all material respects to the Contracts. # TWENTIETH CENTURY INVESTORS

An order has been issued on an application filed by Twentieth Century Investors, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 13(a)(2), 13(a)(3), 18(f)(1), 22(f), and 22(g) of the Act and Rule 2a-7 thereunder; under Sections 6(c) and 17(b) of the Act for an exemption from Section 17(a)(1); and under Section 17(d) of the Act and Rule 17d-1 thereunder permitting certain joint transactions. The order permits applicants to enter into deferred compensation arrangements with certain of their directors and effect transactions incident to those arrangements. (Rel. IC-20650 - October 25)

### COLONIAL TRUST I

An order has been issued under Section 6(c) of the Investment Company Act exempting applicants and certain registered open-end investment companies from Sections 13(a)(2), 13(a)(3), 18(a), 18(c), 18(f)(1), 22(f), 22(g), and 23(a) of the Act, and Rule 2a-7 thereunder, and under Section 17(d) of the Act and Rule 17d-1 thereunder. The order permits each applicant investment company and certain other registered openend investment companies to establish deferred compensation plans for its trustees who are not affiliated persons of the company's investment adviser or principal underwriter. # COLONIAL UNITED STATES EQUITY INDEX TRUST

An order has been issued under Section 8(f) of the Investment Company Act declaring that Colonial United States Equity Index Trust has ceased to be an investment company as defined under the Act. (Rel. IC-20648 - October 24)

# JERSEY CENTRAL POWER & LIGHT COMPANY

A supplemental order has been issued authorizing Jersey Central Power & Light Company, an electric utility subsidiary company of General Public Utilities Corporation, a registered holding company, to extend the time, through December 31, 1999, during which it may acquire customer obligations in connection with certain energy conservation programs in the same amount of \$15 million, as approved previously, and incur administrative and other related expenses in an increased amount of up to \$750,000. ### ORDER GRANTING ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the <u>American Stock Exchange</u> (SR-AMEX-94-44) under Section 19(b) of the Exchange Act relating to the commencement of the use of the New York Stock Exchange's Overnight Comparison System. (Rel. 34-34880)

The National Association of Securities Dealers (NASD) has filed with the Commission, pursuant to Rule 19b-4 under the Securities Exchange Act a proposed rule change (SR-NASD-94-53) providing for technical amendments to the NASD's transaction reporting rules.
