SECTION 16 LETTER INDEX BY SUBJECT MATTER

The Division of Corporation Finance has released an index organizing by subject matter Section 16 letters issued through November 1. ENFORCEMENT PROCEEDINGS

CEASE AND DESIST PROCEEDINGS INSTITUTED AGAINST MANUFACTURERS AND TRADERS TRUST COMPANY

The Commission announced that it instituted cease and desist proceedings pursuant to Section 21C of the Securities Exchange Act against Manufacturers and Traders Trust Company. The Commission simultaneously accepted the offer of settlement of M&T in which the respondent, without admitting or denying the findings of the Order, consented to an Order that it cease and desist from violating Section 7(d) of the Exchange Act and Regulation U promulgated by the Federal Reserve Board and cease and desist from being a cause of violations of Section 7(f) of the Exchange Act and Regulation X promulgated by the Federal Reserve Board. M&T was ordered to disgorge \$141,564, plus interest of \$8,432. In addition, M&T was ordered to retain a consultant to assure future compliance with the above stated credit provisions.

The Commission found that, during the period from at least October 1, 1992 through at least May 3, 1993, M&T violated Section 7(f) of the Exchange Act and Regulation U promulgated by the Federal Reserve Board by extending credit to a customer for the purpose of buying or carrying margin stock, in amounts which exceeded 50% of the purchase price. In addition, the Commission found that M&T was a cause of the customer's violations of Section 7(f) of the Exchange Act and Regulation X promulgated by the Federal Reserve Board, by allowing the customer to pay for purchases of securities with the proceeds from the sales of the same securities. FINAL JUDGMENT ENTERED AGAINST HOMER FORSTER AND CENTER FOR FINANCIAL PLANNING

On September 21, the United States District Court for the Northern District of Georgia entered a final judgment by default against Center for Financial Planning, Inc. (CFP), a registered investment adviser, located in Atlanta, Georgia, and its president and chief executive officer, Homer W. Forster (Forster). The final judgment permanently enjoins the defendants from violating Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 and Sections 206(1) and 206(2) of the Investment Advisers Act and orders the defendants to disgorge \$1,604,708.50, plus prejudgment interest in the amount of \$56,656.24, and to pay a civil penalty in the amount of \$100,000 each.

Previously, the Court on January 13 granted the Commission's application for a temporary restraining order and other emergency relief against the defendants and on February 7 entered a preliminary injunction against them. In its complaint, the Commission alleged that Forster, in late December 1993, redeemed over \$1.6 million in variable annuity contracts belonging to six clients of CFP without their authorization or consent. Forster then had the proceeds wired to a CFP bank account in Georgia from which he withdrew almost all of the funds. [SEC v. Homer W. Forster, et al., Civil Action No. 1 94-CV-0084-JEC, N.D. JUDGMENT ENTERED AGAINST PIONEER INTERNATIONAL HOLDINGS

The Commission announced that on October 21, the Court of Queen's Bench of Alberta, Judicial District of Calgary entered a judgment against Pioneer International Holdings, Ltd. (Pioneer Holdings) in the amount of \$995,405.27 (Cnd.) in the Commission's action.

The Commission had previously filed a Statement Of Claim in the Court of Queen's Bench against Pioneer Holdings on September 1, seeking to recover \$606,258 (U.S.) in disgorgement and \$127,328 (U.S.) in prejudgment interest that Pioneer Holdings had been ordered to pay on June 20, by the United States District Court for the Western District of North Carolina in SEC v. Donald R. Moore, et al., Civil Action No. 5:93-CV97-V, W.D.N.C. The District Court found that Pioneer Holdings, along with other defendants, participated in a fraudulent scheme to sell stock and certificates of deposit to more than 300 investors throughout the United States and several foreign countries by using various misrepresentations and omissions. DISTRICT COURT ENJOINS PRIME BANK FRAUD

On November 1, the United States District Court for the District of Columbia granted the Commission's motion for a temporary restraining order against Fulcrum Holding Company, Inc. (Fulcrum), a District of Columbia corporation, and its chief executive officer Arthur R. Andrews (Andrews). The Commission's complaint alleged that the defendants had fraudulently induced an individual to invest \$1.5 million in nonexistent prime bank bills of exchange and had then used the money to fund their extravagant lifestyle. The Order prohibits defendants from violating the antifraud provisions of the securities laws, freezes their assets, and prohibits Andrews from exiting the United States. [SEC v. Fulcrum Holding Company, Inc., and Arthur R. Andrews, U.S. District Court for the District of Columbia, Civil Action No. 94-2352] (LR-14316)

INVESTMENT COMPANY ACT

DFA DIMENSIONS GROUP

A notice has been issued giving interested persons until November 25 to request a hearing on an application by DFA Dimensions Group, Inc. (the Fund), Dimensional Fund Advisors, Inc. (DFA), and a class of life insurance companies and their separate accounts for an order pursuant to Section 6(c) of the Investment Company Act. The order would grant exemptions from Sections 9(a), 133(a), 15(a), and 15(b) to the extent necessary to permit shares of the Fund to be offered and sold to variable annuity and variable life insurance separate accounts issued by both affiliated and unaffiliated life insurance companies. (Rel. IC-20667 - October 31)

FIDELITY INVESTMENT LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until November 25, to request a hearing on an application by Fidelity Investment Life Insurance Company (FILI), Fidelity Investments Variable Annuity Account I (the Separate Account) and Fidelity Brokerage Services, Inc. (FBSI) for an order, pursuant to Section 6(c) of the Investment Company Act (the Act), granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction from the assets of the Separate Account or similar separate accounts established and maintained by FILI (together, FILI Accounts) of mortality and expense risk charges imposed under certain flexible purchase payment deferred variable annuity contracts (Contracts) and contracts offered in the future that are substantially similar in all material respects to the contracts (future contracts). Applicants also request that the exemptive relief granted to FBSI extend to any other broker-dealer that is a member of the National Association of Securities Dealers and controlling, controlled by, or under common control with FILI, that may serve in the future as principal underwriter for the contracts or future contracts offered through the FILI Accounts. THE TRAVELERS LIFE AND ANNUITY COMPANY

A notice has been issued giving interested persons until November 24 to request a hearing on an application filed by The Travelers Life and Annuity Company (Travelers), The Travelers Fund VA for Variable Annuities and Other Separate Accounts (Separate Accounts), and Travelers Equities Sales, Inc. (collectively, Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Accounts in connection with the issuance and sale of certain flexible premium deferred variable annuity contracts and certificates issued by Travelers. (Rel. IC-20669 - October 31)

CAPITAL EXCHANGE FUND

An order has been issued on an application filed by Capital Exchange Fund, Inc., et al., under Sections 6(c) and 17(b) of the Investment Company Act granting an exemption from Sections 13(a)(2), 13(a)(3), 17(a)(1), 18(a), 18(c), 18(f)(1), 11(f), 22(g) and 23(a) of the Act, and under Section 17(d) and Rule 17d-1 thereunder. The order permits certain investment companies to enter into deferred compensation arrangements with their independent trustees. (Rel. IC-20671 - November 1)

VAN KAMPEN MERRITT EQUITY OPPORTUNITY TRUST, SERIES 1

An order has been issued on an application filed by Van Kampen Merritt Equity Opportunity Trust, Series 1, et al., under Section 6(c) of the Investment Company Act for an exemption from Sections 14(a) and 19(b) of the Act, and Rule 19b-1 thereunder. The order exempts the sponsor of the Trust from having to take for its own account or place with others 100,000 worth of units in the Trust, and permits the Trust to distribute capital gains dividends along with the Trust's other distributions. (Rel. IC-20672 - November 1)

WSIS SERIES TRUST

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting applicants from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1thereunder. The order permits certain open-end management investment companies to issue multiple classes of shares representing interests in the same portfolio of securities, and assess and, under certain circumstances, waive a contingent deferred sales change on certain redemptions of shares. (Rel. IC-20673 - November 1)

GOVERNMENT SECURITIES EQUITY TRUST

A notice has been issued giving interested persons until November 28 to request a hearing on an application filed by Government Securities Equity Trust, et al. for an order permitting respective series of the Trust to invest in shares of an open-end investment company and U.S. Treasury zero coupon obligations. The order would also exempt the Trust's sponsor from having to take for its own account or place with others \$100,000 worth of units in the Trust and, additionally, permit the Trust to distribute capital gains resulting from redemptions of investment company shares within a reasonable time after receipt. The order would permit certain offers of exchange involving the Trust and permit certain affiliated transactions involving the Trust. (Rel. IC-20674 - November 1)

JELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted under Rule 19b-4 by the <u>New York Stock Exchange</u> (SR-NYSE-94-32) to extend the pilot for auxiliary closing procedures for market-at-the-close orders utilized on expiration Fridays and quarterly expiration days until October 31, 1995. (Rel. 34-34916)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change submitted by the <u>American Stock Exchange</u> (SR-AMEX-94-43) under Rule 19b-4 to permit entities with new organizational structures to become member organizations. (Rel. 34-34917)

The Commission granted temporary accelerated approval to a proposed rule change submitted by the <u>Boston Stock Exchange</u> (SR-BSE-94-13) under Rule 19b-4 to implement, on a pilot basis until October 31, 1995, certain procedures for the handling of market-on-close orders on Expiration Fridays and Quarterly Index Expiration days. (Rel. 34-34918)

The Commission granted accelerated approval to a proposed rule change submitted by the <u>Boston Stock Exchange</u> (SR-BSE-94-14) under Rule 19b-4 to rebate certain fees to its member firms for the month of September, 1994. (Rel. 34-34919)

The Commission approved on an accelerated basis a proposed rule change (SR-MCC-94-12) filed by the <u>Midwest Clearing Corporation</u> under Section 19(b) of the Securities Exchange Act. The proposed rule change relates to entering into contracts with participants to provide transactional processing services on behalf of participants. (Rel. 34-34921)

NOTICE OF FILING AND IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-PHLX-94-40) filed by the <u>Philadelphia Stock</u> <u>Exchange</u> relating to the automatic execution of index option orders has become effective pursuant to Section 19(b)(3)(A) of the Securities Exchange Act. Publication of the notice is expected in the <u>Federal</u> <u>Register</u> during the week of November 7. (Rel. 34-34920)
