INVESTMENT COMPANY ACT RELEASES

CHUBB LIFE INSURANCE COMPANY OF AMERICA

An order has been issued correcting a prior order (Investment Company Act Release No. 20600) exempting Chubb Life Insurance Company of America (Chubb Life), Chubb Separate Account CA-1 (Chubb Separate Account), The Colonial Life Insurance Company of America (Colonial Life), Colonial Separate Account VA-2 (Colonial Separate Account), and Chubb Securities Corporation from the provisions of Section 26(a)(2)(2) of the Investment Company Act to the extent necessary to permit the deduction of mortality risk charges and expense risk charges from the assets of the Chubb Separate Account and the Colonial Separate Account under certain individual flexible payment deferred variable annuity contracts issued by Chubb Life and Colonial Life, respectively.
