COMMISSION ANNOUNCEMENTS

SEC'S DIRECTOR OF MARKET REGULATION ANNOUNCES HIS RESIGNATION

On January 25, William Heyman, Director of the Division of Market Regulation, announced his resignation from the SEC, effective March 18th. It is anticipated that he will return to the private sector. Mr. Heyman was appointed Director of the Division of Market Regulation by Chairman Breeden on May 17, 1991. He had served as the Deputy Director since February 14, 1991. (Press Rel. 93-1)

INVESTMENT COMPANY ACT RELEASES

USF&G MONEY MARKET FUNDS, INC.

A notice has been issued giving interested persons until February 19, 1993 to request a hearing on an application filed by USF&G Money Market Funds, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-19230 - January 25)

FIDELITY INVESTMENTS LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until February 19, 1993 to request a hearing on an application filed by Fidelity Investments Life Insurance Company, Fidelity Investments Variable Annuity Account I (Account) and Fidelity Brokerage Services, Inc. for an order pursuant to Section 6(c) of the Investment Company Act. The order would grant exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Account under certain variable annuity contracts. (Rel. IC-19231 - January 25)

STEADMAN FINANCIAL FUND

A notice has been issued giving interested persons until February 22, 1993 to request a hearing on an application filed by Steadman Financial Fund for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-19232 - January 26)

TITAN INSTITUTIONAL INVESTMENTS, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Titan Institutional Investments, Inc. has ceased to be an investment company. (Rel. IC-19233 - January 26)

THE MUNDER FUNDS, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting The Munder Funds, Inc., et al. from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The exemptions apply to the extent necessary to permit the applicants to impose a contingent deferred sales charge (CDSC) on certain redemptions of shares and to waive the CDSC under certain circumstances. (Rel. IC-19234 - January 26)

THE ALLIANCE FUND, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act to amend a prior order that exempts The Alliance Fund, Inc., et al. from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. (Rel. IC-19235 - January 26)

ALLMERICA FUNDS, ET AL.

A notice has been issued giving interested persons until February 22, 1993 to request a hearing on an application filed by Allmerica Funds, et al. for a conditional order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The exemptions apply to the extent necessary to permit applicants to impose a contingent deferred sales charge (CDSC) on certain redemptions of shares and to waive the CDSC under certain circumstances. (Rel. IC-19236 - January 26)

THE PARK AVENUE PORTFOLIO

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting applicant from the provisions of Section 12(d)(3) of the Act to the extent necessary to permit it to invest in equity and convertible debt securities of foreign issuers engaged in securities-related activities, provided that such investments comply with proposed amended Rule 12d3-1 under the Act. (Rel. IC-19237; International Series Rel. 519 - January 26)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The <u>New York Stock Exchange</u> filed a proposed rule change (SR-NYSE-92-36) to amend NYSE Rule 103A to enhance performance standards relating to the turnaround time for specialist's handling of orders received by the Designated Order Turnaround (DOT) system. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 1. (Rel. 34-31760)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>Pacific Stock Exchange</u> (SR-PSE-92-44) to establish a fee for the routine monitoring of capital for certain alternate specialists has become effective upon filing. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 1. (Rel. 34-31761)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the <u>New York Stock Exchange</u> (SR-NYSE-92-28) to amend its Notice of Fine for Minor Violation(s) of Rules to indicate that Form BD does not require disclosure of any uncontested fine of \$2,500 or less, imposed pursuant to Rule 476A. (Rel. 34-31762)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
