## ADMINISTRATIVE PROCEEDINGS

---

### PROCEEDINGS INSTITUTED AGAINST ALEXANDER STEIN

On June 5, 1993, the Commission instituted public proceedings under Sections 203(e) and (f) of the Investment Advisers Act of 1940 against Alexander V. Stein of Portland, Oregon based on allegations that he was convicted in the U.S. District Court for the District of Oregon of thirty-five counts of securities fraud, mail fraud, wire fraud and money laundering. A hearing will be held to determine what, if any remedial action is appropriate in the public interest. (Rel. IA-1378)

### PROPOSED RULE CHANGE

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
