ADMINISTRATIVE PROCEEDINGS

EXEMPTION FROM REGISTRATION SUSPENDED FOR SECURITIES OF AIR TECH INDUSTRIES, INC.

The Commission has issued an order temporarily suspending the Regulation A exemption from registration under the Securities Act of 1933, as amended, with respect to the offering of securities of Air Tech Industries, Inc. (Air Tech).

According to the order, the Commission has reason to believe that securities of Air Tech are being offered in violation of Section 17(a) of the Securities Act of 1933, as amended, because Air Tech is distributing to offerees an offering statement or other sales literature containing untrue statements of material facts and omitting to state material facts necessary in order to make the statements made, in light of the circumstances under which they were made, not misleading, with respect to, for example, Air Tech's assets and management, and because such offering statements and other sales literature have not been filed with the Commission. INVESTMENT COMPANY ACT RELEASES

GNA INVESTORS TRUST, ET AL.

A notice has been issued giving interested persons until September 7, 1993 to request a hearing on an application filed by GNA Investors Trust, et al. for a conditional order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) and Rule 22c-1 thereunder. The conditional order would permit certain open-end management investment companies to issue multiple classes of shares representing interests in the same portfolio of securities and assess and, under certain circumstances, waive a contingent deferred sales charge on certain redemptions of shares. (Rel. IC-19627 - August 13)

NICHOLAS-APPLEGATE CAPITAL MANAGEMENT, ET AL.

A notice has been issued giving interested persons until September 9, 1993 to request a hearing on an application filed by Nicholas-Applegate Capital Management (Adviser), et al. for an order under Section 17(b) of the Investment Company Act exempting applicants from the provisions of Section 17(a). The order would permit two private

investment companies advised by the Adviser to transfer their assets and liabilities to the Emerging Growth Qualified Portfolio of Nicholas-Applegate Mutual Funds in exchange for shares of the portfolio. Such shares would then be issued to the owners of interests in the two private investment companies. (Rel. IC-19628 - August 16)

KEYPORT LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until September 10, 1993 to request a hearing on an application filed by Keyport Life Insurance Company, SteinRoe Variable Investment Trust (Trust), Crown America Holding Company, Crown American Life Insurance Company, Crown America Variable Life Separate Account, Crown America Variable Annuity Separate Account and Crown America Series Fund, Inc. (Fund). The application is for an order pursuant to Section 6(c) of the Investment Company Act and Rule 17d-1 thereunder granting exemptions from the provisions of Section 17(d) of the Act and Rule 17d-1 thereunder. The exemptions apply to the extent necessary to permit them to consummate a Stock Purchase and Reorganization involving the merger of the Trust and the Fund. (Rel. IC-19629 - August 16)

CITIZENS ACQUISITION FUND, L.P.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Citizens Acquisition Fund, L.P. has ceased to be an investment company. (Rel. IC-19630 - August 17)

SUNAMERICA CAPITAL APPRECIATION FUND, INC., ET AL.

An order has been issued on an application filed by SunAmerica Capital Appreciation Fund, Inc., et al. under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. (Rel. IC-19631 - August 17)

NUVEEN INCOME FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that Nuveen Income Fund has ceased to be an investment company. (Rel. IC-19632 - August 17)

THE MARCETTE FUND, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that The Marcette Fund, Inc. has ceased to be an investment company. (Rel. IC-19633 - August 17)

CENTENNIAL CONNECTICUT TAX EXEMPT TRUST

An order has been issued under Section 8(f) of the Investment Company Act declaring that Centennial Connecticut Tax Exempt Trust has ceased to be an investment company. (Rel. IC-19634 - August 17)

OPPENHEIMER BLUE CHIP FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that Oppenheimer Blue Chip Fund has ceased to be an investment company. (Rel. IC-19635 - August 17)

BANDO MCGLOCKLIN CAPITAL CORPORATION ET AL.

A conditional order has been issued on an application filed by Bando McGlocklin Capital Corporation (Bando McGlocklin) et al. for an amendment to an order under Sections 6(c) and 17(b) of the Investment Company Act. The amended order permits Bando McGlocklin to issue one class of senior security which is a stock, and corrects a citation in the original order. The original order granted exemptions from Sections 8(b), 12(d), 17(a), 18(a), 18(c), 30(a), 30(b), and 30(d), and Rules 8b-16, 30a-1, 30b1-1, and 30d-1 thereunder to permit Bando McGlocklin to establish and operate a wholly-owned subsidiary under the terms of a reorganization in which Bando McGlocklin transferred certain assets, including its small business investment company license, to the subsidiary in exchange for all of the common stock of the subsidiary and the assumption by the subsidiary of certain liabilities of Bando McGlocklin. (Rel. IC-19636 - August 17)

MIDLAND NATIONAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until September 13, 1993 to request a hearing on an application for an order filed by Midland National Life Insurance Company, Midland National Life Separate Account C (Separate Account C), and North American Management that would allow Applicants to deduct a mortality and expense risk charge from the assets of Separate Account C. (Rel. IC-19637 - August 17)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-93-02) that establishes a program relating to comparison procedures for municipal securities transactions. (Rel. 34-32747)

The Commission approved a proposed rule change filed by the Midwest Clearing Corporation (SR-MCC-93-1) to amend various by-laws. (Rel. 34-32749)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-93-43) to defer until a date on or before December 27, 1993, the effectiveness of new Part XIV of Schedule D to the NASD By-Laws. This provision establishes rules and procedures for real-time reporting of members' transactions in securities classified as over-the-counter equity securities (OTC Equity Securities). Publication of the proposal is expected in the Federal Register during the week of August 16. (Rel. 34-32756)
