ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST GORDON GOLDMAN

The Commission instituted and settled administrative proceedings against Gordon K. Goldman pursuant to Rule 2(e) of the Commission's Rules of Practice, 17 C.F.R. § 201.2(e), based on the same conduct that was the subject of the civil complaint against Goldman in SEC v. Gordon K. Goldman, Civil Action No. 93-0180, D.D.C., Lamberth, J. (LR-13823). Pursuant to that settlement, the Commission has entered an order permanently barring Goldman from practicing before the Commission. (Rel. 34-33021; AAE Rel. 497)

CIVIL PROCEEDINGS

CIVIL ACTION AGAINST GORDON GOLDMAN

On October 6, the Commission announced a civil action against Gordon K. Goldman. The lawsuit was based on the conduct of Goldman, a certified public accountant, in his audit of College Bound, Inc.'s financial statements for the fiscal year ended August 31, 1991. In settlement of the lawsuit, Goldman has consented to, and the Court has entered, a permanent injunction enjoining Goldman from violating Section 17(a) of the Securities Act of 1933 (Securities Act), Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act), and Rule 10b-5 promulgated thereunder, and from aiding and abetting others in the violation of Exchange Act Section 13(a) and Rules 12b-20 and 13a-1 promulgated thereunder; and to pay a penalty in the amount of \$25,000 pursuant to Securities Act Section 20(d) and Exchange Act Section 21(d)(3). [SEC v. Gordon K. Goldman, Civil Action No. 93-0180, D.D.C., Lamberth, J.] (LR-13823)

COMPLAINT FILED AGAINST DONALD MOORE, ET AL.

The Commission announced that on September 30, 1993 a complaint was filed in the U.S. District Court for the Western District of North Carolina seeking permanent injunctions, accountings, disgorgement with prejudgment interest, and civil penalties against Donald R. Moore (Moore) individually and d/b/a International Society of Investors, George Landen (Landen), Pioneer Development Bank, Inc. (Pioneer Inc.), Pioneer Development Bank, Ltd. (Pioneer Ltd.), Pioneer International Holdings, Ltd., and Fidelity Assurance Guaranty, Inc. alleging violations of antifraud provisions of the Securities Act and Securities Exchange Act.

The Commission's complaint alleges that from September 1990 through December 1991, Moore, who operated and controlled each of the corporate defendants, and Landen sold shares of stock in Pioneer Inc. and certificates of deposit issued by Pioneer Inc. and Pioneer Ltd. to hundreds of investors throughout the United States and several foreign countries, raising at least \$540,000. The complaint alleges that Moore and Landen made numerous misrepresentations and omissions of material facts to investors, concerning, among other things, the returns such securities would provide to investors, the safety of these investments, and the operations and status of Pioneer Inc. and Pioneer Ltd. and the expertise of their management. INVESTMENT COMPANY ACT RELEASES

ALEX. BROWN CASH RESERVE FUND, INC., ET AL.

A conditional order has been issued on an application filed by Alex. Brown Cash Reserve Fund, Inc., et al. under Section 6(c) of the Investment Company Act exempting the applicants from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits certain investment companies to assess and, under certain circumstances, waive a contingent deferred sales charge on certain redemptions of their shares. (Rel. IC-19776 - October 12)

SHEARSON LEHMAN BROTHERS MULTIPLE OPPORTUNITIES PORTFOLIO L.P.

A notice has been issued giving interested persons until November 8, 1993 to request a hearing on an application filed by Shearson Lehman Brothers Multiple Opportunities Portfolio L.P. for an order pursuant to Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-19777 - October 12)

COMSTOCK PARTNERS STRATEGY FUND, INC., ET AL.

A notice has been issued giving interested persons until November 8, 1993 to request a hearing on an application filed by Comstock Partners Strategy Fund, Inc., et al. for an order under Section 6(c) of the Investment Company Act that would amend an order exempting the Fund from Sections 18(f), 18(g), 18(i) of the Act. The order would amend the prior order permitting the Fund to issue two classes of shares by modifying a condition. (Rel. IC-19778 - October 12)

HOLDING COMPANY ACT RELEASES

APPALACHIAN POWER COMPANY

A supplemental order has been issued authorizing Appalachian Power Company, an electric public-utility subsidiary company of American Electric Power Company, Inc., a registered holding company, to effect the refunding of up to \$40 million of pollution control revenue bonds issued in connection with the financing of pollution control facilities. (Rel. 35-25906)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The American Stock Exchange filed a proposed rule change (SR-AMEX-93-25) relating to the listing and trading of options on the North American Telecommunications Index. Publication of the proposal is expected in the Federal Register during the week of October 11. (Rel. 34-33035)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-NASD-93-50) filed by the National Association of Securities Dealers relating to the extension of the Nasdaq International Service Pilot Program. Publication of the proposal is expected in the Federal Register during the week of October 11. (Rel. 34-33037; International Series Rel. 590)

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
