U.S. SECURITIES EXCHANGE COMMISSION

ADMINISTRATIVE PROCEEDINGS

SOCIETE DES TUYAUX BONNA ORDERED TO CEASE AND DESIST

On October 14, the Commission issued an Order Instituting Cease and Desist Proceedings under Section 21C of the Securities Exchange Act of 1934 and Findings and Order against Societe Des Tuyaux Bonna (Bonna), a French corporation with its principal offices in Paris, France. The Order requires Bonna to permanently cease and desist from committing or causing any violation of or any future violation of Section 16(a) of the Exchange Act and Rules 16a-2 and 16a-3 promulgated thereunder. Simultaneously, the Commission accepted Bonna's Offer of Settlement in which, without admitting or denying the matters set forth in the Order, it consented to the issuance of the Order. The Order finds that during the period from February 10, 1988, through June 11, 1992, Bonna filed late twelve Forms 4, required to be filed by Section 16(a) of the Exchange Act and the rules thereunder, reporting its transactions with respect to the registered equity securities of Ameron, Inc., which transactions had a total value in excess of \$1.4 million. Orders have been issued under Section 8(f) of the Investment Company Act declaring that the above-named companies have ceased to be investment companies. (Rels. IC-19779, IC-19780 and IC-19781, respectively - October 13)

LEHMAN BROTHERS INC.

A conditional order has been issued on an application filed by Lehman Brothers Inc. (Lehman) under Section 9(c) of the Investment Company Act exempting Lehman from Section 9(a) of the Act for a period of one year to the extent necessary to permit Lehman to employ an individual who is subject to a securities-related injunction. (Rel. IC-19782 - October 13)

THE ONE GROUP, ET AL.

A notice has been issued giving interested persons until November 8, 1993 to request a hearing on an application filed by The One Group, et al., for an order under Section 6(c) of the Investment Company Act that would grant an exemption from Section 12(d)(1)(A)(ii), under Sections 6(c) and 17(b) that would grant an exemption from Section 17(a), and under Rule 17d-1 to permit certain transactions in accordance with Section 17(d) and Rule 17d-1. The order would permit certain money market funds to sell their shares to affiliated investment companies. (Rel. IC-19783 - October 13)

STATE STREET BANK AND TRUST COMPANY

A notice has been issued giving interested persons until November 8, 1993 to request a hearing on an application filed by State Street Bank and Trust Company for an order under Sections 6(c) and 17(b) of the Investment Company Act that would exempt applicant from Section 17(a). The order would permit applicant to engage in principal transactions with any series of an investment company of which applicant is an affiliated person of an affiliated person solely because of an investment advisory relationship with another series of that investment company, and any investment company of which applicant is an affiliated person of an affiliated person solely because of an investment advisory relationship with another investment company under common control with that investment company. (Rel. IC-19784 - October 13)

THE HANOVER FUNDS, INC., ET AL.

A notice has been issued giving interested persons until November 8, 1993 to request a hearing on an application filed by The Hanover Funds, Inc., et al. for a conditional order under Section 6(c) of the Investment Company Act. The order would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder, and would permit applicants to issue and sell separate classes of shares representing interests in the same portfolio of securities, and to assess and, under certain circumstances, waive a contingent deferred sales charge on redemptions of certain shares. HOLDING COMPANY ACT RELEASES

OHIO POWER COMPANY

A supplemental order has been issued regarding a proposal by Ohio Power Company, an electric public-utility subsidiary company of American Electric Power Company, Inc., a registered holding company, to effect by June 30, 1994 the refunding of up to \$50 million of pollution control revenue bonds issued in connection with the financing, pursuant to an installment sale agreement, of pollution control facilities. Also, the Commission releases jurisdiction over the terms of the sale of those facilities. (Rel. 35-25907)
