CIVIL PROCEEDINGS

AMERICAN SPORTS ADVISORS, INC. ENJOINED

The Commission announced that on June 23 the U.S. District Court for the District of Columbia entered a Final Judgment of Permanent Injunction against American Sports Advisors, Inc. of Garden City, New Jersey. The Judgment restrained and enjoined American from failing to file timely periodic reports and Notifications of Late Filing.

In its April 3 complaint, the Commission alleged that American, as part of a continuing course of violative conduct extending over several years, failed to file its Annual Report on Form 10-K for its fiscal year ended October 27, 1985 and its Quarterly Report on Form 10-Q for its fiscal quarter ended February 3, 1986. The complaint further alleged that in connection with the failure to file these periodic reports, American failed to file required Notifications of Late Filing on Form 12b-25. American, consenting to the Court's Judgment, admitted that it had filed late three Annual and 12 Quarterly Reports and failed to file 15 Notifications of Late Filing. (SEC v. ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the prior percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
