## ADMINISTRATIVE PROCEEDINGS

### RULE 2(e) PROCEEDING INSTITUTED AGAINST ROBERT E. NILSSEN AND DON F. OLIVER

The Commission issued an Order Instituting Proceedings and Opinion and Order under Rule 2(e) of the Commission's Rules of Practice against Robert E. Nilssen, a certified public accountant and partner in KMG Main Hurdman's San Francisco office, and Don F. Oliver, also a certified public accountant and formerly an audit manager with that office. The Order denies these accountants the privilege of appearing or practicing before the Commission but allows resumption (after 12 months for Nilssen and 6 months for Oliver) upon a showing of satisfaction of specified educational and professional association requirements. Nilssen and Oliver consented to the Order without admitting or denying the findings therein.

The Order finds that these accountants engaged in improper professional conduct within the meaning of Rule 2(e), in that Nilssen and Oliver did not properly audit the 1983 financial statements of Tri-Comp Sensors, Inc. and Nilssen did not properly audit the 1983 financial statements of Citel, Inc. The findings primarily concern failures to properly audit related party transactions. (Rel. 34-23617; AAER-111) [see also LR-11214 concerning a related injunctive action.]

## CIVIL PROCEEDINGS

### CIVIL INJUNCTIVE ACTION FILED AGAINST TRI-COMP, INC., OTHERS

The San Francisco Branch Office filed a complaint on September 10 in federal district court in San Jose, California against nine defendants, seeking permanent injunctions against violations relating to securities registration, fraud in the offer and sale of securities, issuer periodic reporting, proxy solicitation, securities ownership reporting, and misrepresentations to auditors. The violations alleged include misappropriations of offering proceeds raised from public investors, misappropriation of stock, filing of fraudulent Securities Exchange Act reports and unregistered securities offerings. The defendants include Ralph L. Vaerst, of Hillsborough, California, and several companies, attorneys and businessmen associated with him, namely, Tri-Comp Sensors, Inc., Embarcadero Capital Corporation, attorneys William D. Sauers and Michael J. Ackerman, Bruce A. Welge, Jerry D. Rampelberg, Victor Shurcole and George S. Land. (SEC v. Vaerst, et al., Civ. No. C-86-52-28, NDCA). (LR-11214)

### METLIFE HOLDINGS, INC.

An order has been issued permitting a subsidiary of Metlife Holdings, Inc. to issue debt securities and non-voting preferred stock. (Rel. IC-15300 - Sept. 10)

### THE EVERGREEN TOTAL RETURN FUND, INC.

An order has been issued granting a retroactive exemption from all provisions of the Investment Company Act to The Evergreen Total Return Fund, Inc. and its investment advisers, Saxon Woods Asset Management Corp. and Lieber & Company, for certain transactions relating to an overissuance of Fund shares.
