

CIVIL PROCEEDINGS

COMPLAINT NAMES UNIVERSAL ENERGY CORPORATION, OTHERS

The Commission filed a civil action on March 1 against Universal Energy Corporation of Tulsa, Oklahoma (UEC), Robert A. Alexander, Jr., Michael F. Rogers, Leo C. Stith, Mingo Valley Industries, Inc., Armstrong Royalty Corporation, Robert J. Herald, Ronald D. Kelsey, Jerry L. Gentry and James L. Diamond. The complaint alleges violations of the registration, antifraud, reporting, accounting, proxy and officer/ beneficial ownership filing provisions of the securities laws. Without admitting or denying the allegations in the complaint, the defendants, with the exception of Diamond, consented to Final Judgments of Permanent Injunction and Other Equitable Relief. Among other things the relief provides for the appointment of a Special Master for UEC and the payment of UEC stock by two individual defendants to UEC.

The complaint alleges that from about April 1, 1981 to the present, Alexander, Stith, Mingo Valley, Herald, Armstrong, Kelsey and Gentry, in concert with others, manipulated the price of UEC stock. It was further alleged that Alexander funded this course of action, in part, by: an unregistered distribution of approximately one million shares of UEC stock to the public (about 20% of the total authorized shares of UEC common stock during that period) by Alexander and Diamond, aided and abetted by Herald, Gentry and others; and the misapplication of UEC's assets by Alexander directly and through Mingo Valley. (SEC v. Universal Energy Corporation, et al., USDC DC, Civil Action No. 84-0643). (LR-10299)

RICHARD L. BURNS AND DAVID W. WATT CHARGED WITH FRAUD

The Commission filed a complaint on February 23 in the U.S. District Court for the Southern District of California seeking injunctive relief against Richard L. Burns, former Chairman of the Board and Chief Executive Officer of Nucorp Energy, Inc., and David W. Watt, formerly Nucorp's President and Chief Financial Officer. The complaint alleges that the defendants violated the antifraud and reporting provisions of the securities laws.

The complaint alleges that: from at least December 1980 to October 1981, Burns and Watt caused Nucorp Supply, Inc., a Nucorp subsidiary, to improperly recognize revenue upon receipt of an order for goods and prior to either shipment of the goods or receipt of payment; this practice caused Nucorp's financial statements to materially overstate income and/or revenue during that period; the materially false financial statements were used in the purchase and sale of Nucorp securities and were filed with the Commission in certain annual and quarterly reports; and, in an unrelated matter, Burns induced Nucorp subsidiary executives to purchase Nucorp common stock at a time when Nucorp was making a public distribution of common stock, in violation of Rule 10b-6 under the Securities Exchange Act of 1934.

Simultaneously with the filing of the complaint, Watt consented to a Final Judgment of Permanent Injunction against him without admitting or denying the allegations in the Commission's complaint. (SEC v. Richard L. Burns and David W. Watt, USDC SDCA, Civil Action No. 84-0454-K). (LR-10298)

CORRECTION RE SWINK & COMPANY, INC.

In the News Digest of February 29, under "Civil Proceedings," the caption for Swink & Company, Inc. incorrectly stated that the Broker-dealer and its President were barred. In fact, the defendants were not barred, but enjoined. The Commission has determined not to seek administrative sanctions based solely on the injunction or the underlying conduct.

WRIGHT INVESTMENT SHARES, INC.

A notice has been issued giving interested persons until March 23 to request a hearing on an application by Wright Investment Shares, Inc. for an order declaring that it has ceased to be an investment company. (Rel. IC-13795 - Feb. 27)

EXEMPT ASSETS PORTFOLIOS

A notice has been issued giving interested persons until March 23 to request a hearing on an application by Exempt Assets Portfolios, a registered open-end, diversified, management investment company, for an order exempting it from the provisions of Sections 2(a)(41) and 12(d)(3) of the Investment Company Act and Rules 2a-4 and 22c-1. The exemption will enable Applicant to value standby commitment rights, in the manner described in the application, and permit the acquisition of such rights from brokers or dealers. (Rel. FRANKLIN BUILDING ASSOCIATES, LIMITED PARTNERSHIP

A notice has been issued giving interested persons until March 23 to request a hearing on an application of Franklin Building Associates, Limited Partnership, and Milk Street Residential Associates, Limited Partnership, for an order exempting Franklin from all provisions of the Investment Company Act. (Rel. IC-13798 - Feb. 28)

SELF-REGULATORY ORGANIZATIONS

NOTICE OF PROPOSED RULE CHANGES

The National Association of Securities Dealers, Inc. filed proposed rule changes under Rule 19b-4 (SR-NASD-84-2) to amend the NASD's Rules of Fair Practice to require that any sales incentives provided by a sponsor, affiliate of a sponsor or program to a broker-dealer in the public distribution of a Direct Participation Program be in the form of cash. The NASD states that this restriction will simplify recordkeeping requirements for broker-dealers and enhance their ability to control the participation of their salespersons in such programs. (Rel. 34-20698); and (SR-NASD-84-1) that would modify several sections of the NASD's Uniform Practice Code. The proposal amends Sections 9(c) of the Code, relating to "Don't Know" (DK) notices, and Section 12 of the Code that sets forth the requirements for time and place of delivery of securities. In addition, the proposal deletes Section 5(b)(3) of the Code relating to the designation of ex-dividend dates of investment company shares and Section 30 that requires that a third party witness an assignment of certificates or a power of substitution. Publication of the proposals are expected to be made in the <u>Federal Register</u> during the week of February 27.
