COMMISSION ANNOUNCEMENTS

NEWS DIGEST LISTING OF SECURITIES ACT REGISTRATIONS WILL BE AUTOMATED

Beginning Monday, March 26, the Securities Act Registrations list will be compiled by computer, saving many hours of staff time. The only difference between the old and new systems will be the exclusion of an indication that a filing is a rights offering or a shelf registration, and an approximate three-day increase between filing and appearance in the News Digest.

ADMINISTRATIVE PROCEEDINGS

PATRICK MICHAEL BARRED

The Commission barred Patrick Michael of Memphis, Tennessee from association with any broker or dealer. The Findings and Order Imposing Remedial Sanctions against Michael found that he wilfully violated the registration and antifraud provisions of the securities laws. The Order further found that Michael had been enjoined from further violations of the registration provisions on January 29, 1980 by the U.S. District Court for the Western District of Tennessee. These sanctions were imposed after Michael failed to file an answer to the Order for Proceedings dated December 9, 1983, which alleged, in part, that Michael and others had offered and sold unregistered evidences of indebtedness or investment contracts of G. Weeks Securities, Inc. and that the antifraud provisions of the securities laws had been violated. (Rel. 34-20731)

INVESTMENT COMPANY ACT RELEASES

THOMSON MCKINNON INVESTMENT TRUST

A notice has been issued giving interested persons until April 9 to request a hearing on an application of Thomson McKinnon Investment Trust for an order exempting it from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Investment Company Act and Rules 22c-1 and 22d-1. CONSOLIDATED NATURAL GAS COMPANY

Temporary prepayments of \$50 million from excess cash to Consolidated and cash advances from Consolidated previously allowed to Supply Corporation are to be changed so that such transactions will be carried out by Transmission Corporation following the transfer to Transmission Corporation of all of Supply Corporation's assets and related liabilities other than its natural gas utility business in West Virginia. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

Rule changes filed by the following have become effective in accordance with Section 19(b)(3)(A) of the Securities Exchange Act of 1934: The Options Clearing Corporation (SR-OCC-84-2) which amends Interpretation and Policy No. 2 to OCC Rule 604. Under the proposal, OCC will calculate each clearing member's maximum allowable amount of letters of credit from non-U.S. institutions based on the clearing member's aggregate OCC margin deposit. (Rel. 34-20756); and The Pacific Stock Exchange, Inc. (SR-PSE-84-4) to reduce the fee charged to its member firms for the costs of providing computer terminal equipment for PSE's on-line automated options trade check system. (Rel. 34-20757)

NOTICE OF PROPOSED RULE CHANGE

The Pacific Clearing Corporation filed a proposed rule change (SR-PCC-84-4) that would amend several provisions of PCC's guidelines for approving U.S. and non-U.S. institutions as issuers of letters of credit for PCC's participants fund.
