## NOTICE OF COMMISSION MEETINGS

CHANGE IN THE MEETING: ITEM RESCHEDULED

The May 1 open meeting to consider a legislative proposal to implement the Commission's responses to the recommendation of the Tender Offer Advisory Committee has been rescheduled to Wednesday, May 9 at 10:00 a.m.

## ADMINISTRATIVE PROCEEDINGS

PERMANENT SUSPENSION OF THE REGULATION A EXEMPTION OF ACTION SERVICE, INC.

The Commission issued an order permanently suspending the Regulation A exemption from registration respecting a proposed public offering of securities by Action Service, Inc. of Dallas, Texas.

According to the order, the Commission has reason to believe that the notification and offering circular contains untrue statements of material facts and omissions to state material facts necessary in order to make the statements made, in light of the circumstances under which they were made, not misleading, particularly respecting: (1) an undisclosed promoter; (2) the promoter's control of Action and his activities as a de facto officer and the fact that the named officers and director play little or no role in the management of Action; (3) the amount of time the officers would devote to Action, the services to be rendered by each, and the officers' current employment status; and (4) the anticipated use of proceeds.

Since no hearing was requested by Action within 30 days after the entry of the February 3 order of temporary suspension, the Commission ordered, under Rule 261 of Regulation A of the General Rules and Regulations of the Securities Act of 1933, that the Regulation A exemption of Action be permanently suspended. ## **CIVIL PROCEEDINGS**

RANDY NEAL VALLEN ENJOINED

The Commission announced that on April 4 a Final Judgment of Permanent Injunction was entered against Randy Neal Vallen of Memphis, Tennessee by the U.S. District Court for the Western District of Tennessee. The Order, which was entered under Vallen's consent, prohibits him from further violations of the registration and antifraud provisions of the securities laws. Vallen neither admitted nor denied the allegations of the complaint, except as specifically found and concluded by the trial court and the appellate court.

The complaint alleged that Vallen and others offered and sold unregistered securities and that they violated the antifraud provisions of the securities laws while associated with G. Weeks & Company, Inc., a registered Memphis, Tennessee brokerdealer. (SEC v. G. Weeks Securities, Inc., et al., Civil Action No. C-A-2711-G, W.D. TN). (LR-10353)
