ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST BLINDER ROBINSON AND MEYER BLINDER

> The Commission instituted public administrative proceedings against Blinder, Robinson & Co., Inc. (Blinder Robinson), a registered broker-dealer whose principal office is located in Englewood, Colorado, and Meyer Blinder (Blinder), its president and controlling shareholder. The Order for Proceedings alleges that on June 8, 1982 the U.S. District Court for the District of Colorado permanently enjoined Blinder Robinson and Blinder from violating certain antifraud and anti-manipulative provisions of the securities laws. The Crder also alleges that Blinder Robinson wilfully violated and Blinder wilfully violated and wilfully aided and abetted violations of certain antifraud and anti-manipulative provisions of the securities laws in the 1979-1980 public offering of the securities of American Leisure Corp.

A hearing will be scheduled to determine whether the allegations are true and whether any remedial actions should be taken by the Commission. (Rel. 34-21123)

INVESTMENT COMPANY ACT RELEASES

AMERICAN GROWTH FUND, INC.
