COMMISSION ANNOUNCEMENTS

GARY LLOYD AND PATRICIA G. BELL NAMED ASSISTANT REGIONAL ADMINISTRATORS IN LOS ANGELES

Irving M. Einhorn, Los Angeles Regional Administrator, appointed Gary Lloyd and Patricia G. Bell as Assistant Regional Administrators for Enforcement and Regulation, respectively.

Mr. Lloyd graduated from Kent State University with a B.A. in 1969, and received his J.D. from Case Western Reserve University in 1973. He was in private practice from 1973 to 1980, and then joined the Federal Energy Regulatory Commission, where he was most recently the Acting Assistant General Counsel for Enforcement. Mr. Lloyd's appointment was effective April 30, 1984.

Ms. Bell graduated from Brown University in 1974, and received her J.D. from Boston University School of Law in 1978. She worked in private practice before joining the Commission's staff in 1980 as an enforcement attorney in the Los Angeles Regional Office. She also worked as an attorney in the Full Disclosure program and then served as a Branch Chief in Enforcement, before again taking a job in the private sector. Ms. Bell assumed her present position in June 1984.

CIVIL PROCEEDINGS

ROBERT D. WHEAT ENJOINED

The Denver Regional Office announced that on July 16 Judge Richard Matsch, U.S. District Court for the District of Colorado, entered a permanent injunction against Robert D. Wheat, Sr. of Englewood, Colorado. Wheat, without admitting or denying the allegations in the July 9 complaint, consented to the injunction which restrains him from violating the antifraud, reporting and accounting provisions of the Securities Exchange Act of 1934.

According to the complaint, Wheat caused Oiltech, Inc., a publicly-traded oil and gas company of which he was president and controlling shareholder from 1978 through August 1981, to file with the Commission and publicly disseminate several documents containing false and misleading statements. Among other things, the annual report on Form 10-K and the annual report to shareholders for 1980 allegedly overstated the company's income before income taxes by 44%. Also, the quarterly reports on Form 10-Q filed with the Commission for the first three quarters allegedly overstated income before taxes for each reporting period, exceeding actual income before taxes by 93% in the statement for the first nine months of 1981. STATE BANK OF NEW SOUTH WALES

NOTICE OF PROPOSED RULE CHANGE

The New York Stock Exchange, Inc. filed a proposed rule change under Rule 19b-4 (SR-NYSE-84-26). The proposal would extend application for the NYSE's systems for automated order routing, execution reporting and pre-opening order tabulations from only equity orders, to include certain designated options orders (<u>i.e.</u>, the Designated Order Turnaround System, the Limit Order Turnaround System, and the Opening Automated Report Service. Publication of the proposal is expected to be made in the Federal Register during the week of July 23. (Rel. 34-21157)
