ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

KEITH R. ABRAMS BARRED

The Commission instituted public administrative proceedings under the Exchange Act against Keith R. Abrams of New York, New York. Simultaneously with the institution of proceedings, the Commission accepted an Offer of Settlement in which Abrams, without admitting or denying the alleged violations, except admitting that he has been previously convicted of mail fraud in the Southern District of New York, consented to findings of violations and to a bar from association with any broker or dealer.

Specifically, the Commission found that Abrams, while employed as an account executive at a registered broker-dealer, wilfully violated the antifraud provisions of the Exchange Act by engaging in unauthorized transactions in customers' accounts, misappropriating securities, creating fictitious accounts for his own trading, falsifying brokerage records to conceal his fraudulent activities and misrepresenting to customers that their accounts were doing well when, in fact, they had incurred losses. The Commission also found that Abrams had been convicted in the Southern District of New York of mail fraud. (Rel. 34-21338)

INVESTMENT COMPANY ACT RELEASES

CRITERION ACCEPTANCE CORPORATION

HOLDING COMPANY ACT RELEASES

INDIANA & MICHIGAN ELECTRIC COMPANY

A notice has been issued giving interested persons until October 22 to request a hearing on a proposal by Indiana & Michigan Electric Company, subsidiary of American Electric Power Company, Inc., to dispose of and acquire pollution control facilities. (Rel. 35-23438 - Sept. 28)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on an accelerated basis, a proposed rule change filed by the National Association of Securities Dealers, Inc. (SR-NASD-84-24) to provide a rebate to subscribers to last sale information in NASDAQ/NMS securities. The NASD states that it is granting this rebate because Market Services, Inc.'s net income for fiscal year 1984 is expected to be in excess of accumulated amount of net operating losses, start up expenses, and investment tax credits. APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Chicago Board Options Exchange, Inc. (SR-CBOE-84-20) to revise CBOE's policies and procedures with regard to granting exemptions to position and exercise limits under CBOE Rules 4.11 and 4.12. (Rel. 34-21358)

IMMEDIATE EFFECTIVENESS OF A PROPOSED RULE CHANGE

A rule change filed by The Options Clearing Corporation (SR-OCC-84-14) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal establishes a Delivery-Versus-Payment System for settling foreign currency. options exercises. Clearing members could elect to use the DVP System, instead of the regular procedures under OCC Rule 1606, for large deliveries of foreign currency. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of September 24. (Rel. 34-21359)
