PROPOSAL TO AMEND RULES 17Ad-5 AND 17Ad-10

The Commission proposes for public comment amendments to Securities Exchange Act Rules 17Ad-5 and 17Ad-10. The proposed amendment to Rule 17Ad-5 would require registered transfer agents to respond to securityholder inquiries regarding unpaid dividend and interest claims within certain time frames. The proposed amendment to Rule 17Ad-10 would expand the time frame within which transfer agents must buy in securities in the event of certain actual physical overissuances and would clarify certain operational aspects of the rule.

AMENDMENTS TO RULES 17Ad-1 and 17Ad-2 ADOPTED

The Commission adopted amendments to Securities Exchange Act Rules 17Ad-1 and 17Ad-2. The amendments require low-volume transfer agents that handle depository-eligible securities issues to process or transfer 90% of all routine items within five business days of receipt. (Rel. 34-21375)
