CIVIL PROCEEDINGS

U.S. SECURITIES AND EXCHANGE COMMISSION

FINAL JUDGMENT OF PERMANENT INJUNCTION ENTERED AGAINST NEW STAR CORPORATION, OTHERS

The Denver Regional and the Salt Lake City Branch Offices announced that on October 9 Judge Bruce S. Jenkins, U.S. District Court for the District of Utah, entered final judgments of permanent injunction against New Star Corporation of Salt Lake City, Utah, Kenneth E. Brailsford of Springville, Utah, and Wynn L. Westmoreland of Provo, Utah. The judgments enjoin the defendants from future violations of the registration and antifraud provisions of the securities laws. The defendants consented to the judgments without admitting or denying the allegations of the September 28 complaint. The complaint also named Gary L. Davis of Bountiful, Utah as a defendant in the action for permanent injunction. The civil action against Davis is still in progress. (SEC v. New Star Corp., et al., USDC UT, Civil Action No. C-84-0876J). (LR-10589)

INVESTMENT COMPANY ACT RELEASES

FIRST INVESTORS TAX EXEMPT FUND, INC.

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on an accelerated basis, a proposed rule change filed by the New York Stock Exchange, Inc. (SR-NYSE-84-39) to extend the time period for the NYSE to test the operation of the Registered Representative Response Service (R4) for 60 days from November 7, 1984, the scheduled expiration date, so that the Commission may act on the NYSE's request, as submitted in a companion 19b-4 filing, that the R4 program be extended to November 7, 1985. APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Midwest Stock Exchange, Inc. (SR-MSE-84-4) to amend Article XXX, Rule 1, Interpretations and Policies .01 of the MSE rules, to increase the number of days the Committee on Specialist Assignment and Evaluation or a designated subcommittee thereof has to deliberate on and respond to written agreements or proposals to exchange existing assignments submitted by specialists before such proposals become effective from 10 to 30 days. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Pacific Stock Exchange, Incorporated filed a proposed rule change which became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The rule change (SR-PSE-84-19) amends the PSE's Options Floor Procedure Advice F-4 which provides standards of dress and conduct on the PSE Options Trading Floor.
