

CIVIL PROCEEDINGS

MARKETING WORKSHOP, INC., OTHERS ENJOINED

The Chicago Regional Office announced that on October 19 Judge Thomas R. McMillen, U.S. District Court for the Northern District of Illinois, entered an Order of Permanent Injunction against Marketing Workshop, Inc., Flagship International, Inc. and Eileen Avanzino of Chicago, Illinois. The defendants consented to the Order of Permanent Injunction without admitting or denying the complaint's allegations.

The complaint alleged that: the defendants violated the registration and antifraud provisions of the securities laws in the offer and sale of unregistered securities in the form of investment contracts called memberships of Flagship; these memberships cost \$200 each; there was no limit to the number of memberships an investor could purchase; investors were promised a \$1,000 return in approximately four weeks from each membership purchased; investors were not told how many memberships were sold at the time of and prior to their investment, therefore, investors were unable to determine the likelihood of receiving the promised return; and investors were told nothing about the risk of the investment or how much of the investment was retained by the defendants. (SEC v. Marketing Workshop, Inc., et al., ND IL, Civil Action No. 84-C-4400, filed 5/23/84). (LR-10593)

CRIMINAL PROCEEDINGS

CHARLES GARBER PLEADS GUILTY

The New York Regional Office announced that on October 29 Charles Garber pleaded guilty in federal court in Manhattan to participation in a scheme to trade in securities based on material non-public information stolen from the New York financial printing concern of Bowne of New York City, Inc. Garber, an ex-foreman of Bowne, pleaded guilty to one count of conspiracy, two counts of mail fraud, one count of obstructing a federal grand jury investigation and one count of obstructing an SEC investigation. Sentencing is scheduled for December 10, 1984. (U.S. v. Charles Garber). (LR-10592)

INVESTMENT COMPANY ACT RELEASES

FOREST CITY INVESTMENT PARTNERS II LIMITED PARTNERSHIP

An order has been issued on an application of Forest City Investment Partners II Limited Partnership, a District of Columbia limited partnership, and its general partner, Forest City Dillon, Inc., exempting the Partnership from all provisions of the Investment Company Act. (Rel. IC-14227 - Nov. 7)

CITIES SERVICE OIL AND GAS CORPORATION

STORAGE EQUITIES, INC.
