U.S. SECURITIES AND EXCHANGE COMMISSION

COMPLAINT NAMES JACOB F. BUTCHER, OTHERS

The Atlanta Regional Office filed a complaint on November 9 in the U.S. District Court for the Eastern District of Arkansas against Jacob F. Butcher, of Orlando, Florida, former chief executive officer of the failed United American Bank in Knoxville, Tennessee (UABK), George W. Ridenour, Jr., formerly a UABK director and General Counsel, and Jesse A. Barr, a consultant to Butcher, both of Knoxville, Tennessee. The complaint seeks preliminary and permanent injunctions against future violations of the antifraud provisions of the securities laws in the offer and sale of UABK Series B common stock and the offer of yet to be authorized UABK preferred stock.

The complaint alleges that the defendants, in violation of the antifraud provisions, made misrepresentations and omitted to state material facts about the financial condition of UABK, particularly its need for millions in new capital, and self-dealing by the defendants. The complaint also alleged misrepresentations concerning Butcher's personal financial condition. (SEC v. Jacob F. Butcher, et al., Civil Action No. LR-C-84-942, ED AK). (LR-10612)

CRIMINAL PROCEEDINGS

RICHARD OPPENHEIM SENTENCED

Edward S.G. Dennis, Jr., U.S. Attorney for the Eastern District of Pennsylvania, and the Washington Regional Office announced that on November 1 Richard M. Oppenheim of Holmdel, New Jersey, a broker for certain tax shelter syndications sold by the Fidelity America Mortgage Company (FAMCO), was placed on five years probation, ordered to pay \$30,000 in fines and ordered to perform three years of community service. In imposing sentence, Daniel H. Huyett 3rd, U.S. District Judge for the Eastern District of Pennsylvania, cited Oppenheim's cooperation with the Government in the FAMCO investigation as being important in not imposing a prison term.

Oppenheim was indicted on November 8, 1982 on one count of conspiracy to defraud the Internal Revenue Service and two counts of tax evasion in his attempt to avoid \$134,175 of taxes on commissions of \$272,570 received from FAMCO during 1979 and 1980. Oppenheim is the fourth person to have been sentenced to date in the Fidelity America Finance Company (FAFCO/FAMCO) frauds. The FAFCO/FAMCO schemes involved fraud in the sale of "mortgage secured notes" and industrial development bonds issued by FAMCO between 1978 and 1981, fraud in the sale of a real estate tax shelter syndication, and various charges involving tax evasion. NOTICE OF PROPOSED RULE CHANGES

Proposed rule changes have been filed under Rule 19b-4 by: The Philadelphia Stock Exchange, Inc. (SR-Phlx-84-26) to permit the introduction of series of stock options with strike prices of \$5.00, and strike price intervals of \$5.00 for options on stocks trading over \$100 per share. (Rel. 34-21502); The Midwest Stock Exchange, Inc. (SR-MSE-84-9) to amend Article I, Rule 1 of its Rules to impose conditions on those foreign members which do not maintain offices in the United States and which are responsible for preparing and maintaining financial and other reports required to be filed with the Commission and the MSE.
