U.S. SECURITIES AND EXCHANGE COMMISSION

## HOWARD GOODSTEIN MAKES PARTIAL RESTITUTION

The Commission announced that on November 14 Howard Goodstein of North Miami Beach, Florida, delivered certain funds following a previously filed plea agreement. Goodstein, formerly associated with a registered broker-dealer as a branch office manager, was charged by information with two counts of securities fraud in violations of Sections 10(b) and 32 of the Securities Exchange Act of 1934.

Goodstein tendered approximately \$69,000 to each of his two elderly victims. Goodstein and his wife, who was not involved in her husband's misconduct, tendered \$15,000, which represented the proceeds from their bank accounts, and approximately \$122,000, which represented the proceeds from the sale of their house. They also signed an agreement to deliver the proceeds from their monthly pension distribution to the elderly victims, who each will receive approximately \$100 per month for ten years. Goodstein and his wife also assigned their interests in their respective money market accounts at a registered broker-dealer. Their accounts collectively total approximately \$100,000. (U.S. v. # HOLDING COMPANY ACT RELEASES

### YANKEE ATOMIC ELECTRIC COMPANY

A notice has been issued giving interested persons until December 17 to request a hearing on a proposal by Yankee Atomic Electric Company, subsidiary of New England Electric System and Northeast Utilities, to issue and sell up to an aggregate outstanding principal amount of \$15 million of short-term notes to banks and/or commercial paper to dealers through December 31, 1986. ### MIDDLE SOUTH ENERGY, INC.

A memorandum opinion and order has been issued authorizing a proposal by Middle South Energy, Inc., subsidiary of Middle South Utilities, Inc., to enter into installment sales agreements with Claiborne County, Mississippi, regarding the financing of pollution control facilities at Grand Gulf Nuclear Electric Generating Station through the issue and sale by the County of up to \$250 million in pollution control revenue bonds, and to issue and pledge first mortgage bonds. The Arkansas Public Service Commission filed objections in this proceeding which were overruled. (Rel. 35-23495 - Nov. 23)

### GEORGIA POWER COMPANY

A notice has been issued giving interested persons until December 19 to request a hearing on a proposal by Georgia Power Company, subsidiary of The Southern Company, to issue first mortgage bonds for sinking fund purposes. (Rel. 35-23496 - Nov. 23)

### NOTICE OF PROPOSED RULE CHANGES

Proposed rule changes have been filed by: The Midwest Clearing Corporation and The Midwest Securities Trust Company (SR-MCC-84-9 and SR-MSTC-84-8) which would require applicants for MCC/MSTC membership and broker-dealer participants to furnish responses to a questionnaire to MCC/MSTC relating to the applicant's or participant's financial and operational status. (Rel. 34-21509); The New York Stock Exchange, Inc. (SR-NYSE-84-36) to institute rate increases affecting initial and continuing annual listing fees for both equity securities and bonds. (Rel. 34-21510); and The Boston Stock

Exchange, Inc. (SR-BSE-84-7) to amend Chapter XV of the Rules of the Board of Governors to implement new procedures pertaining to the registration of dealer-specialists and to the minimum number of stocks required of each dealer-specialist. (Rel. 34-21514)

### IMMEDIATE EFFECTIVENESS OF A PROPOSED RULE CHANGE

A rule change filed by the Pacific Securities Depository Trust Company has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposed rule change (SR-PSDTC-84-14) would amend PSDTC's fee schedule by including a charge for deposits of bearer securities that are convertible to registered form. The proposed fee would be \$5.00 per deposit plus \$.04 per \$1,000 of face value in excess of \$50,000. (Rel. 34-21511)
