PROPOSED AMENDMENTS TO INSTRUCTIONS TO FORM 13F

The Commission proposes for public comment amendments to the instructions to Form 13F under the Securities Exchange Act of 1934. The amendments would simplify the procedures for requesting confidential treatment of certain risk arbitrage positions filed on the form, and place time limitations on confidential treatment requests for securities holdings where the holdings constitute confidential commercial information.

Comments should be submitted in triplicate to Shirley E. Hollis, Acting Secretary, Securities and Exchange Commission, 450 Fifth Street, NW, Washington, DC 20549. Comments must be received by January 14, 1985 and refer to File No. S7-40-84. All submissions will be available for public inspection at the Public Reference Room. (Rel. 34-21539)

COMMISSION ANNOUNCEMENTS

JOHN WHEELER APPOINTED SECRETARY TO THE COMMISSION

Chairman John S.R. Shad has appointed John Wheeler Secretary to the Commission, effective December 9, 1984. He succeeds George A. Fitzsimmons, who died last August. Mr. Wheeler has been Special Counsel to the Chairman since 1982.

Mr. Wheeler, 39, joined the Commission in 1978. He worked as Legal Assistant to Commissioner Roberta Karmel, Assistant General Counsel, and Special Counsel to the Director of Corporation Finance. In 1981, Mr. Wheeler was appointed National Director of the President's Vietnam Veterans Leadership Program. He returned as Special Counsel to the Chairman.

Mr. Wheeler received a B.S. degree with distinction from West Point and earned an M.B.A. from Harvard Business School. Following service in Vietnam, he earned a J.D. degree from Yale Law School, where he was Note and Comment Editor of the Law Journal. Mr. Wheeler then clerked for Judge George MacKinnon on the U.S. Court of Appeals for the District of Columbia. Before joining the Commission, he was associated with Shea & Gardner.

As a volunteer, Mr. Wheeler serves as Chairman of the Vietnam Veterans Memorial Fund, the group responsible for building the memorial on the Washington Mall. He recently authored Touched With Fire: The Future of the Vietnam Generation.

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
