## **ADMINISTRATIVE PROCEEDINGS**

AGO HOLDING N.V. CITED

The Commission has issued its Order Instituting Proceedings pursuant to Section 15(c)(4) of the Securities Exchange Act of 1934 and Findings and Order Imposing Remedial Sanctions against AGO Holding N.V. AGO consented to the entry of the Commission's Findings and Order without admitting or denying any of the matters contained therein.

In its Order, the Commission found that AGO failed to comply with Section 13(d) of the Exchange Act and the rules and regulations promulgated thereunder. Specifically, the Commission found that AGO failed to disclose for over one year purchases of Life Investors, Inc. common stock made for its account by a Dutch nominee totalling approximately 1.4 percent of the outstanding shares of Life Investors, Inc. common stock. The Commission found that AGO's first disclosure concerning these purchases, contained in Amendment Number 7 to its Statement pursuant to Section 13D, misrepresented the date, price, method and nature of the purchases. The second disclosure, contained in Amendment Number 10 to the Schedule 13D, did not identify the nominee or the circumstances surrounding the transactions.

The Commission ordered AGO to comply with Section 13(d) of the Exchange Act and the rules and regulations thereunder, amend its Schedule 13D attaching a copy of the Commission's Findings and Order and comply with its undertaking to adopt and maintain procedures, including reporting and review procedures, reasonably designed to assure compliance with Section 13(d) of the Exchange Act. #### CIVIL PROCEEDINGS

#### COMPLAINT NAMES JAMES L. DOUGLAS

The Chicago Regional Office announced that on January 18 a complaint was filed in the U.S. District Court for the Northern District of Ohio, Western Division, seeking to enjoin James L. Douglas, also known as James L. Cooper (Douglas) from violations of the registration and antifraud provisions of the securities laws. On that day the Court entered an order of permanent injunction against Douglas for these violations. Douglas consented to the entry of the injunction without admitting or denying the allegations contained in the Commission's complaint.

The Commission's complaint alleges, among other things, that from December 1976 to the present, Douglas offered and sold interests in at least 45 limited and general partnerships to in excess of 300 investors, residing in at least six states, raising more than \$7,500,000 in cash and recourse promissory notes. The partnerships were formed for the purpose of investing in oil and gas programs.

The complaint further alleges that in the offer and sale of the partnership interests Doulgas, among other things, commingled the funds raised from investors, overcharged for the drilling of wells, made highly inflated profit projections without any basis in fact, failed to disclose the interests of persons unrelated to the partnership in the partnerships' leaseholds and failed to disclose the extent of compensation he was to receive.

The Court also ordered the parties to begin negotiations with respect to the appropriateness of ordering ancillary relief in this case. The parties are to report to the Court within 90 days on the status of those negotiations. (SEC v. James L. Douglas, aka James L. Cooper, U.S.D.C. N.D. Ohio, Western District, Civil File No. C82-29).
