U.S. SECURITIES AND EXCHANGE COMMISSION

ADOPTION OF AMENDMENTS TO RULES 13a-11, 13a-13, 15d-11, and 15d-13; TO FORMS 8-K, 10-Q, AND 10-K; AND TO SCHEDULE 14A OF REGULATION 14A

The Commission announced the adoption of amendments to the periodic disclosure forms, related rules, and disclosure schedule for proxies and information statements. Included among the revisions are amendments that would: (1) require registrants to file reports on Form 8-K within fifteen days after the occurrence of one of the events specified in the form or within ten days after the end of the month during which occurred an event reported under the voluntary disclosure item; (2) decrease the number of items of information required to be included in reports on Form 8-K by eliminating two items and transferring seven items to the Form 10-Q; (3) add a new item to Form 8-K requiring disclosure of bankruptcy or receivership proceedings; (4) revise two of the items retained in the Form 8-K and four of those transferred to the Form 10-Q; (5) provide for disclosure in the Form 10-K of items previously required in reports on Form 8-K; and (6) revise Item 5 of Schedule 14A to Regulation 14 under the Exchange Act to conform to the amendment of Item 1 of Form 8-K.

The amendments relating to the time for filing reports on the Form 8-K and to Schedule 14A shall be effective for events which occur subsequent to February 28, 1977. The amendments to Rules 13a-13 and 15d-13 and to Form 10-Q shall be effective for quarterly periods beginning after December 31, 1976. The amendments to the Form 10-K shall be effective for reports filed for periods beginning after March 31, 1976. (Rel. 34-13156)

COMMENT PERIOD EXTENDED ON PROPOSED DISCLOSURE RULES RELATING TO BROKERAGE PLACEMENT PRACTICES AND POLICIES OF INVESTMENT MANAGERS

The SEC extended the comment period on its proposed rules which would require registered investment companies, some other issuers, and certain registered investment advisers to make disclosures to investors about brokerage placement practices and policies, including the use of brokerage commissions to purchase research services (Rel. 33-5772, November 30, 1976 [41 Fed. Reg. 53356 (1976)]), from January 13 to February 14, 1977. Accordingly, all interested persons are invited to submit their views and comments on the above proposals in triplicate to George A. Fitzsimmons, Secretary, Securities and Exchange Commission, Washington, D.C. 20549, on or before February 14, 1977. Such comments should refer to File No. S7-660, and will be available for public inspection. (Rel. 33-5798)

COMMISSIONER SPEAKS

STOCK TRANSACTIONS OF SELECTED FINANCIAL INSTITUTIONS AND FOREIGN INVESTORS, FIRST THREE QUARTERS OF 1976

According to estimates released by the SEC, Private noninsured pension funds, open-end investment companies, life insurance companies and property-liability insurance companies purchased \$32.8 billion of common stock and sold \$27.0 billion during the first three quarters of 1976, resulting in net purchases of \$5.8 billion. During the first three quarters of 1975, gross purchases were \$27.3 billion; gross sales were \$23.9 billion; and net purchases were \$3.4 billion. COMMISSION GRANTS REGISTRATION OF NATIONAL SECURITIES CLEARING CORPORATION

The Commission announced that it has granted the registration of National Securities Clearing Corporation (NSCC) as a clearing agency, effective immediately, subject to the terms, conditions and directives contained in the Order, including a condition that the Order may not be implemented by NSCC prior to January 20, 1977.

On March 29, 1976, NSCC filed with the Commission an application for registration as a clearing agency which contemplated, among other things, the performance by NSCC of the clearing and settlement operations currently performed by American Stock Exchange Clearing Corporation(ASECC), National Clearing Corporation (NCC) and Stock Clearing Corporation (SCC). On May 28, 1976, the Commission instituted proceedings to determine whether to grant or deny the application; as part of the proceedings, the Commission provided an opportunity for oral presentation of data, views and arguments on June 16-18, 1976

On November 3, 1976, the Commission announced it was considering approving the NSCC application subject to four proposed conditions and requested public comment on the proposed conditions. On the basis of the Commission's review, analysis and evaluation of the data, views and aggments on the NSCC application and Commission releases issued in connection with the application, the Commission has granted registration to NSCC subject to the terms, conditions and directives contained in the Order. COURT ENFORCEMENT ACTIONS

INJUNCTIVE ACTION FILED AGAINST SILVER STACK MINES, LTD., OTHERS; PROCEEDING INSTITUTED AGAINST JAMES U. BLANCHARD, III

The Commission announced the filing of a civil injunctive action against Silver Stack Mines, Ltd. (Silver Stack), a Canadian corporation, Charles Dudley Robbins (Robbins), former president, director and shareholder of Silver Stock, and James U. Blanchard, LII, a registered investment adviser, doing business as International Investment Research (Blanchard).

The Commission also announced that the Honorable William Bryant, U.S. District Judge, District of Columbia, entered a judgment of permanent injunction enjoining Robbins and Blanchard from violations of the registration and antifraud provisions of the securities laws and further enjoining Blanchard from violations of the recordkeeping provisions of the securities laws. Robbins and Blanchard consented to the entry of the Court's judgment and order without admitting or denying the allegations of the Commission's complaint.

The Commission's complaint alleges that Silver Stock, Robbins and Blanchard offered for sale and sold to U.S. investors the unregistered securities of Silver Stack in violation of the Securities Act of 1933 (Securities Act) and that Blanchard violated the antifraud and recordkeeping provisions of the Investment Advisers Act of 1940 (Advisers Act).

The Commission further announced that an administrative proceeding has been instituted against Blanchard on the basis of the entry of the judgment of permanent injunction. Blanchard has submitted an offer of settlement which has been accepted by the Commission whereby he is suspended from engaging in the practice and activities of an investment adviser or association with any investment adviser for a period of sixty days. SCHUSTER SPECTRUM FUND

HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until Pebruary 7 to request a hearing on a proposal of General Public Utilities Corporation, a registered holding company, that it amend its Charter to provide for common stockholder preemptive rights in certain circumstances. A notice has been issued giving interested persons until February 7 to request a hearing on a proposal of Jersey Central Power & Light Company, Metropolitan Edison Company and Pennsylvania Electric Company, subsidiaries of General Public Utilities Corporation, that the companies sell various interests in jointly-owned nuclear plants to each other. NOTICE OF EXTENSION OF PUBLIC COMMENT PERIOD ON PROPOSED RULE CHANGES

The New York Stock Exchange, Inc. (NYSE) has filed proposed rule changes under Rule 19b-4 (SR-NYSE-76-54) to permit NYSE specialists and odd-lot dealers to trade listed options upon underlying specialty stocks and stocks for which they act as odd-lot dealers, and to permit all NYSE members including registered traders to trade underlying stocks for which they hold options positions.

The original period for public comment upon the rule change filing expired on November 19, 1976. Subsequently, the time period within which the Commission must act upon the merits of the proposal was extended to February 1, 1977. In view of the significance of the regulatory issues raised by the rule change proposal, the Commission has extended the time for public comment on the proposed rule changes to January 28, 1977. (Rel. 34-13157)

NOTICE OF PROPOSED RULE CHANGE

The Philadelphia Stock Exchange, Incorporated has filed a proposed rule change under Rule 19b-4 (SR-PHLX-76-20) to rescind Exchange Rules 1042 (Member Trading Reports) and 1050 (Reports of Open Exercise Positions). Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of January 17. (Rel. 34-13158)

The Chicago Board Options Exchange, Incorporated (CBOE) has filed a proposed rule change under rule 19b-4 (SR-SBOE-76-26) to amend CBOE Rules 6.45, 6.74, 6.75, 7.4 and 7.5. Publication of the proposal is expected to be made in the Federal Register during the week of January 17. (Rel. 34-13159)
