## **RULES AND RELATED MATTERS**

U.S. SECURITIES AND

UNIFORM NET CAPITAL RULE - EFFECT OF RATINGS OF LXCHANGE COMMISSION

The Commission announced that, effective September 1, in computing net capital under Rule 15c3-1, brokers and dealers may not include short term commercial paper of high quality in the reduced haircut category under the net capital rule unless such paper has two ratings in one of the three highest categories of the nationally-recognized statistical rating organizations. However, the Commission amended the rule to permit the reduced haircuts in such commercial paper bearing only one rating until September 1. (Rel. 34-13635)

SECTION 240.17Ad-5(e) PROPOSED

The Commission announced that it has under consideration for adoption proposed Section 240.17Ad-5(e) under the Securities Exchange Act of 1934, prescribing for registered transfer agents a performance standard for responding to certain investor and broker inquiries which do not qualify for treatment under paragraphs (a) through (d) of Section 240.17Ad-5. All interested persons are invited to submit their views in triplicate to George A. Fitzsimmons, Secretary, SEC, 500 North Capitol Street, Washington, D.C. 20549, no later than August 15. Reference should be made to File No. S7-707. (Rel. 34-13637)

SECTIONS 240.17Ad-1 TO 240.17Ad-7 ADOPTED

The Commission announced the adoption of Sections 240.17Ad-1, 240.17Ad-2, 240.17Ad-3, 240.17Ad-4, 240.17Ad-5, 240.17Ad-6 and 240.17Ad-7 under the Securities Exchange Act of 1934, prescribing performance standards and other requirements for transfer agents registered with the Commission, Comptroller of the Currency, Board of Governors of the Federal Reserve System and Federal Deposit Insurance Corporation. #### **COURT ENFORCEMENT ACTIONS**

RICHARD D. SMITH, SEAFOOD FARMS, INC. ENJOINED

The Chicago Regional Office announced that on June 6 a final judgment of permanent injunction and order granting ancillary relief by consent was entered by the Honorable Alfred Y. Kirkland against Richard D. Smith and Seafood Farms, Inc. The injunction was issued in connection with the fraudulent sale of unregistered limited partnership interests in Coastal Shellfish. Smith and Seafood were enjoined from further violations of the registration and antifraud provisions of the securities laws. The defendants were also ordered to provide the court an accounting of all funds received from

#### GEORGE APOSTOL INDICTED

The Chicago Regional Office announced the return of a 23-count indictment by a Federal Grand Jury in Chicago, Illinois, on April 19 charging George Apostol, of Chillicothe, Missouri, with violations of the mail fraud statute and perjury. Apostol was charged with making false and misleading statements concerning the success of operations of his company, Pan America Land Research, Inc., the guarantee of dividends of at least 12% annually, and the preparation of Pan America's balance sheet by a certified public accountant. The indictment also alleges that Apostol failed to inform investors that Pan America never made a profit from operations and that Apostol converted funds from Pan America's checking account to his own personal use and benefit. (U.S. v. George Apostol, N.D. Illinois, Civil Action No. 77-CR-366). (LR-7977)

#### THREE SPOKANE RESIDENTS ENJOINED

The Seattle Regional Office announced that on May 25 Judge Marshall A. Neill entered orders of permanent injunction by consent against Francis D. Duval (Duval), and Vance D. McCarty (McCarty) of Spokane, Washington for violations of the registration and antifraud provisions of the securities laws and against Mrs. Estelle Duval (Mrs. Duval) the transfer agent, for registration violations. Duval and McCarty, officers and directors of Gold Reserve Corporation (GRC) were enjoined from selling unregistered securities of GRC and Pegasus Explorations Ltd. (Pegasus) in violation of the registration and antifraud provisions of the securities laws. Additional ancillary relief required: Duval to resign his positions as president and director of GRC for three years and disgorge 25,000 shares of Pegasus to GRC; McCarty to disgorge 20,000 shares of Pegasus to GRC and Duval and McCarty to disgorge 1.8 million GRC treasury shares to GRC. The defendants consented to entry of the injunction without admitting or denying the allegations of the complaint. (U.S. v. Francis D. Duval, Vance D. McCarty, E.D. Wash., Civil Action No. 75-233). ## **HOLDING COMPANY ACT RELEASES**

#### LOUISIANA POWER & LIGHT COMPANY

A notice has been issued giving interested persons until July 12 to request a hearing on the proposal of Louisiana Power & Light Company, subsidiary of Middle South Utilities, Inc., to amend the company's Articles of Incorporation to increase the amount of preferred stock, \$100 par value, which the company is authorized to have outstanding. (Rel. 35-20078 - June 17)

#### BRITISH AMERICAN UTILITIES CORPORATION

A supplemental notice has been issued extending until July 15 the period during which interested persons may request a hearing on a plan filed by British American Utilities Corporation and its sole and wholly-owned subsidiary, North East Heat & Light Company, for the reorganization of the British American holding company system. # **SELF-REGULATORY ORGANIZATIONS**

#### NOTICE OF PROPOSED RULE CHANGE

The Midwest Clearing Corporation has filed a proposed rule change pursuant to Rule 19b-4 (SR-MCC-77-3) which would provide for the automatic allocation of securities held in loan free positions to long value positions. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of June 20. (Rel. 34-13640)

The Boston Stock Exchange, Inc. has filed a proposed rule change under Rule 19b-4 (SR-BSE-77-2) to amend a number of its Constitutional provisions pertaining to member-ship provisions and the duties of certain Exchange committees. Publication of the proposal is expected to be made in the Federal Register during the week of June 20. (Rel. 34-13642)

#### NOTICE OF EFFECTIVENESS OF A RULE CHANGE

The National Securities Clearing Corporation (NSCC) has filed pursuant to Rule 19b-4 a rule change establishing a fee of \$25 to be charged in an issuer for a report of the free position balances of NCC Division Clearing Members in the issuer's securities.

The rule change (SR-NSCC-77-4) has become effective in accordance with Section 19(b)(3) (A) of the Securities Exchange Act of 1934. Publication of the submission is expected to be made in the Federal Register during the week of June 20. (Rel. 34-13643)

#### APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the Midwest Stock Exchange, Inc. (SR-MSE-77-9) to amend Rule 22 of its Rules and Practices for Trading (Charges by Member and Specialist for Execution of Orders) to modify language which relates back to the time when fixed rates were still in existence.
