DECISIONS IN ADMINISTRATIVE PROCEEDINGS

SUSPENSION OF GEORGE WASSON EFFECTIVE

On June 21, the U.S. Court of Appeals for the Eighth Circuit affirmed an order of the Commission suspending George Wasson, of Minneapolis, from association with any broker or dealer for 45 days. The Commission, which had stayed Wasson's suspension pending his appeal, declared the suspension effective as of August 22. (Rel. 34-13823)
