RULES AND RELATED MATTERS

AUDITOR CHANGES PROPOSAL

U.S. SECURITIES AND EXCHANGE COMMISSION

The Commission issued a proposal to amend its Form 8-K and proxy rules regarding the reporting of changes of a registrant's independent accountants to require disclosure of (1) the reasons for such change and (2) whether the decision to change auditors was considered, recommended or approved by the registrant's Board of Directors of its audit committee. Comments should be submitted in triplicate to George A. Fitzsimmons, Secretary, Securities and Exchange Commission, 500 North Capitol Street, Washington, D.C. 20549 on or before November 30, 1977 and should refer to File No. S7-720. All comments will be available for public inspection. (Rel. 33-5868)

DISCLOSURE OF RELATIONSHIPS WITH INDEPENDENT PUBLIC ACCOUNTANTS

The Commission issued a proposal to amend its proxy rules to require disclosure of (1) whether the board of directors or audit committee have approved all services, and (3) the company's revenues derived from the independent auditors. The Commission also requests comments on the nature of services auditors provide their audit clients. Comments should be submitted in triplicate to George A. Fitzsimmons, Secretary, Securities and Exchange Commission, 500 North Capitol Street, Washington, D.C. 20549 on or before November 30, 1977 and should refer to File No. S7-721. INVESTMENT COMPANY ACT RELEASES

FORD INTERNATIONAL CAPITAL CORPORATION
