U.S. SECURITIES AND EXCHANGE COMMISSION

REVISED PROPOSAL TO ADOPT RULE 17f-4

The Commission has announced that it is soliciting public comments on a proposal to adopt Investment Company Act Rule 17f-4. The proposed rule, which has been revised in response to comments on the version of the rule last proposed in Investment Company Act Release No. 9633, would govern the direct or indirect use by registered management companies of certain depository systems for the deposit of such companies' securities. The rule would also permit the use of the joint Federal Reserve-Treasury Department book-entry program for United States government and agency securities. All interested persons are invited to submit written views and comments to George A. Fitzsimmons, Secretary, Securities and Exchange Commission, 500 North Capitol St., Washington, D.C. 20549 by January 13, 1978. Reference should be made to File No. S7-675. FINANCIAL STATEMENT REQUIREMENTS FOR BANK HOLDING COMPANIES AND BANKS

A revised proposal for financial statement requirements for bank holding companies and banks has been issued for public comment. This proposal, known as Article 9 of Regulation S-X, was originally issued for public comment in April 1977 and has been revised to reflect comments on that proposal. MASS MUTUAL CORPORATE INVESTORS
