Dear Mr. Martinez:

On behalf of the State of Kansas, we would like to submit to NTIA a list of priority projects for Round 2 consideration under the Broadband Technology Opportunities Program (BTOP). As you are aware, NTIA provided our state staff with information on 37 projects that showed some impact on Kansas.

Much like in Round 1, the State of Kansas established scoring criteria upon which all participating applicants were evaluated. A high level of emphasis was once again placed on the state's priority areas (telemedicine, distance learning, economic development, e-government), as well as the needs of unserved Kansans. Evaluation criteria were slightly altered to place an added emphasis on projects in counties we feel are in great need of assistance based on demographic and socioeconomic factors among others.

The list of applicants provided by NTIA was utilized in disseminating information about the Kansas scoring process. All applicants were asked to self-score and defend those scores based on the rating criteria. Of the 37 projects contacted, 24 submitted self-score information. A rating team then evaluated all information provided to establish an average score for each project.

Based on our scoring results, we would like to recommend 11 projects to NTIA that we feel meet the established criteria of our state. A listing of these projects, in alphabetical order, is attached.

The State of Kansas would like to note that all projects were evaluated based upon information provided to the State by NTIA and applicants. Due to the tight timeframes on states in this process and a lack of additional data, the State of Kansas did not attempt to validate applicants' claims of meeting the needs of unserved populations. Similarly, the State did not attempt to evaluate whether applications were duplicative of each other's service areas. It is our understanding that providers and other applicants will have a period to voice such concerns through the federal process.

We continue to believe the BTOP program provides great potential for our state as well as the country as a whole. We appreciate the support our projects have received in Round 1 and look forward to continued success in Round 2. If you need anything additional from us, please contact me or one of our program staff dedicated to this effort.
