The key for REGION is as follows:

- 1 = Northeast
- 2 = Midwest
- 3 = South
- 4 = West

The key for DIVISION is as follows:

- 1 = New England
- 2 = Middle Atlantic
- 3 = East North Central
- 4 = West North Central
- 5 = South Atlantic
- 6 = East South Central
- 7 = West South Central
- 8 = Mountain
- 9 = Pacific

The key for SEX is as follows:

- 0 = Total
- 1 = Male
- 2 = Female

The key for ORIGIN is as follows:

- 0 = Total
- 1 = Not Hispanic
- 2 = Hispanic

The key for RACE is as follows:

- 1 = White Alone or in Combination
- 2 = Black or African American Alone or in Combination
- 3 = American Indian and Alaska Native Alone or in Combination
- 4 = Asian Alone or in Combination
- 5 = Native Hawaiian and Other Pacific Islander Alone or in Combination

Note: Hispanic origin is considered an ethnicity, not a race. Hispanics may be of any race.

'In combination' means in combination with one or more other races. The sum of the five race groups adds to more than the total population because individuals may report more than one race.

Responses of "Some Other Race" from the 2010 Census are modified. This results in differences between the population for specific race categories shown for the 2010 Census population in this file versus those in the original 2010 Census data. The April 1, 2010 Population Estimates base reflects changes to the 2010 Census population from the Boundary and Annexation Survey (BAS) and other geographic program revisions. It does not reflect changes from the Count Question Resolution program.
