Traffic Safety Facts 2002

Overview





"In 2002, there were an estimated 6,316,000 policereported traffic crashes, in which 42,815 people were killed and 2,926,000 people were injured; 4,348,000 crashes involved property damage only." Introduction

Motor vehicle travel is the primary means of transportation in the United States, providing an unprecedented degree of mobility. Yet for all its advantages, deaths and injuries resulting from motor vehicle crashes are the leading cause of death for persons of every age from 2 through 33 years old (based on 2000 data). Traffic fatalities account for more than 90 percent of transportation-related fatalities. The mission of the National Highway Traffic Safety Administration is to reduce deaths, injuries, and economic losses from motor vehicle crashes.

Fortunately, much progress has been made in reducing the number of deaths and serious injuries on our nation's highways. In 2002, the fatality rate per 100 million vehicle miles of travel fell to a new historic low of 1.51. The 1992 rate was 1.75 per 100 million vehicle miles traveled. A 75 percent safety belt use rate nationwide and a reduction in the rate of alcohol involvement in fatal crashes — to 41 percent in 2002 from 47 percent in 1992 — were significant contributions to maintaining this consistently low fatality rate. However, much remains to be done. The economic cost alone of motor vehicle crashes in 2000 was \$230.6 billion.

In 2002, 42,815 people were killed in the estimated 6,316,000 policereported motor vehicle traffic crashes, 2,926,000 people were injured, and 4,348,000 crashes involved property damage only.

This overview fact sheet contains statistics on motor vehicle fatalities based on data from the Fatality Analysis Reporting System (FARS). FARS is a census of fatal crashes within the 50 states, the District of Columbia, and Puerto Rico (although Puerto Rico is not included in U.S. totals). Crash and injury statistics are based on data from the General Estimates System (GES). GES is a probability-based sample of police-reported crashes, from 60 locations across the country, from which estimates of national totals for injury and property-damage-only crashes are derived.

Other fact sheets available from the National Center for Statistics and Analysis are Alcohol, Occupant Protection, Speeding, Children, Young Drivers, Older Population, Pedestrians, Pedalcyclists, Motorcycles, Large Trucks, School Transportation-Related Crashes, State Traffic Data, and State Alcohol Estimates. Detailed data on motor vehicle traffic crashes are published annually in Traffic Safety Facts: A Compilation of Motor Vehicle Crash Data from the Fatality Analysis Reporting System and the General Estimates System.

Summary

In 2002, 42,815 people lost their lives in motor vehicle crashes — an increase of 1.5 percent from 2001 (42,196).

The fatality rate per 100 million vehicle miles of travel in 2002 was 1.51. The injury rate per 100 million vehicle miles of travel in 2002 was 103. The fatality rate per 100,000 population was 14.85 in 2002, slightly higher than the 2001 rate of 14.79.

An average of 117 persons died each day in motor vehicle crashes in 2002 — one every 12 minutes.

Motor vehicle crashes are the leading cause of death for every age from 2 through 33 years old.

Vehicle occupants accounted for 87 percent of traffic fatalities in 2002. The remaining 13 percent were pedestrians, pedalcyclists, and other nonoccupants.

Occupant Protection

In 2002, 49 states and the District of Columbia had safety belt use laws in effect. Use rates vary widely from state to state, reflecting factors such as differences in public attitudes, enforcement practices, legal provisions, and public information and education programs.

From 1975 through 2002, it is estimated that safety belts saved 164,753 lives, including 14,164 lives saved in 2002. If *ALL* passenger vehicle occupants over age 4 wore safety belts, 21,317 lives (that is, an additional 7,153) could have been saved in 2002.

In 2002, it is estimated that 376 children under age 5 were saved as a result of child restraint use. An estimated 6,567 lives were saved by child restraints from 1975 through 2002.

Children in rear-facing child seats should not be placed in the front seat of cars equipped with passenger-side air bags. The impact of a deploying air bag striking a rear-facing child seat could result in injury to the child. NHTSA also recommends that children 12 and under sit in the rear seat away from the force of a deploying air bag.

In 2002, 39 percent of passenger car occupants and 41 percent of light truck occupants involved in fatal crashes were unrestrained.

In fatal crashes, 73 percent of passenger vehicle occupants who were totally ejected from the vehicle were killed. Safety belts are effective in preventing total ejections: only 1 percent of the occupants reported to have been using restraints were totally ejected, compared with 30 percent of the unrestrained occupants.

Alcohol

In 2001, NHTSA began using a revised method — multiple imputation to estimate missing information about blood alcohol concentration (BAC) levels for persons involved in fatal crashes. The alcohol estimates in this fact sheet are based on the new imputation method. The new method will enable NHTSA to improve the scope of alcohol involvement statistics generated from the Fatality Analysis Reporting System (FARS). NHTSA has also calculated historical estimates of alcohol involvement from 1982 through 2000 using the new method. Instead of estimating alcohol involvement in the three categories used in the past (0.00, 0.01 to 0.09, and 0.10+ grams per deciliter [g/dl]), the new method estimates BAC levels over the entire range of plausible values from 0.00 to 0.94 g/dl. As a result, NHTSA will have the ability to report alcohol involvement at any BAC level. Because many states have adopted 0.08 g/dl as the legal threshold for alcohol inoxication, NHTSA now estimates alcohol involvement in the following three categories: 0.00 g/dl, no alcohol; 0.01 to 0.07 g/dl, impaired; and 0.08+, intoxicated. More information on the new multiple imputation method, including detailed tabulations of alcohol involvement in various categories (age, sex, time of day, etc.), is available in NHTSA Technical Report DOT HS 809 403, Transitioning to Multiple Imputation: A New Method to Estimate Missing Blood Alcohol Concentration (BAC) Values in FARS.

In 2002 there were 17,419 fatalities in alcohol-related crashes. This is a slight increase (0.1 percent) compared to 2001 (17,400 fatalities), and it represents an average of one alcohol-related fatality every 30 minutes.

The 17,419 alcohol-related fatalities in 2002 (41 percent of total traffic fatalities for the year) represent a 5 percent reduction from the 18,290 alcohol-related fatalities reported in 1992 (47 percent of the total).

NHTSA estimates that alcohol was involved in 41 percent of fatal crashes and in 6 percent of all crashes in 2002.

In 2002, 35 percent of all traffic fatalities occurred in crashes in which at least one driver or nonoccupant had a BAC of 0.08 g/dl or greater.


All states and the District of Columbia now have 21-year-old minimum drinking age laws. NHTSA estimates that these laws have reduced traffic fatalities involving drivers 18 to 20 years old by 13 percent and have saved an estimated 21,887 lives since 1975. In 2002, an estimated 917 lives were saved by minimum drinking age laws.

Approximately 1.4 million drivers were arrested in 2001 for driving under the influence of alcohol or narcotics. This is an arrest rate of 1 for every 137 licensed drivers in the United States (2002 data not yet available).

Intoxication rates for drivers in fatal crashes in 2002 were 31 percent for motorcycles, 23 percent for light trucks, 22 percent for passenger cars, and 2 percent for large trucks.

From 1992 to 2002, intoxication rates (BAC of 0.08 g/dl or greater) decreased for drivers of all age groups involved in fatal crashes, except for the group of drivers 45 to 64 years old, which had the same rates in 1992 and 2002.




Figure 2. Previous Driving Records of Drivers Killed in Traffic Crashes, by Blood Alcohol Concentration, 2002



Speeding

NHTSA has revised the definition of a speeding-related crash. A crash is considered speeding-related if the driver was charged with a speeding-related offense or if an officer indicated that racing, driving too fast for conditions, or exceeding the posted speed limit was a contributing factor in the crash.

Speeding is one of the most prevalent factors contributing to traffic crashes. The economic cost to society of speeding-related crashes is estimated by NHTSA to be \$40.4 billion per year. In 2002, speeding was a contributing factor in 31 percent of all fatal crashes, and 13,713 lives were lost in speeding-related crashes.

For drivers involved in fatal crashes, young males are the most likely to be speeding. The proportion of all crashes that are speeding-related decreases with increasing driver age. In 2002, 39 percent of the male drivers 15 to 20 years old who were involved in fatal crashes were speeding at the time of the crash.

In 2002, 87 percent of speeding-related fatalities occurred on roads that were not Interstate highways.

Alcohol and speeding are clearly a deadly combination. Speeding involvement is prevalent for drivers involved in alcohol-related crashes. In 2002, 42 percent of the *intoxicated* drivers (BAC = 0.08 or higher) involved in fatal crashes were speeding, compared with only 15 percent of the *sober* drivers (BAC = 0.00) involved in fatal crashes.




Figure 4. Speeding Drivers in Fatal Crashes by Age and Sex, 2002


Motorcycles

The 3,244 motorcyclist fatalities in 2002 accounted for 8 percent of all traffic fatalities for the year. An additional 65,000 motorcycle occupants were injured.

Per vehicle mile traveled in 2001, motorcyclists were 26 times as likely as passenger car occupants to die in a motor vehicle traffic crash and 5 times as likely to be injured.



In 2002, 38 percent of all motorcycle drivers involved in fatal crashes were speeding. The percentage of speeding involvement in fatal crashes was approximately twice as high for motorcyclists as for drivers of passenger cars or light trucks, and the percentage of alcohol involvement was 45 percent higher for motorcyclists.

In 2002, 47 percent of fatally injured motorcycle operators and 59 percent of fatally injured passengers were not wearing helmets at the time of the crash.

One out of four motorcycle operators (25 percent) involved in fatal crashes in 2002 was operating the vehicle with an invalid license at the time of the collision.

Motorcycle operators involved in fatal crashes in 2002 had higher intoxication rates (BAC of 0.08 g/dl or greater) than any other type of motor vehicle driver. The intoxication rate for motorcycle operators involved in fatal crashes was 31 percent.

NHTSA estimates that helmets saved the lives of 692 motorcyclists in 2002. If all motorcyclists had worn helmets, an additional 449 lives could have been saved.

Large Trucks

In 2002, 11 percent (4,897) of all the motor vehicle traffic fatalities reported involved large trucks (gross vehicle weight rating greater than 10,000 pounds).

Of the fatalities that resulted from crashes involving large trucks, 79 percent were occupants of another vehicle, 7 percent were nonoccupants, and 14 percent were occupants of a large truck.

Large trucks accounted for 8 percent of all vehicles involved in fatal crashes and 4 percent of all vehicles involved in injury and property-damage-only crashes in 2002.

More than three-quarters (79 percent) of the large trucks involved in fatal crashes in 2002 collided with another motor vehicle in transport.

Only 2 percent of the drivers of large trucks involved in fatal crashes in 2002 were intoxicated, compared with 22 percent for passenger cars, 23 percent for light trucks, and 31 percent for motorcycles.

Cars, Light Trucks, and Vans

In 2002, 32,598 occupants of passenger vehicles were killed in traffic crashes and an additional 2,684,000 were injured, accounting for 88 percent of all occupant fatalities (passenger cars 55 percent, light trucks and vans 33 percent) and 96 percent of all occupants injured (passenger cars 64 percent, light trucks and vans 31 percent).

Occupant fatalities in single-vehicle crashes accounted for 43 percent of all motor vehicle fatalities in 2002. Occupant fatalities in multiple-vehicle crashes accounted for 44 percent of all fatalities, and the remaining 13 percent were nonoccupant fatalities (pedestrians, pedalcyclists, etc.).




Figure 7. Fatalities in Traffic Crashes, 1992 and 2002

In 2002, 59 percent of passenger vehicle occupant fatalities occurred in vehicles that sustained frontal damage.

Ejection from the vehicle accounted for 28 percent of all passenger vehicle occupant fatalities. The ejection rate for occupants of light trucks in fatal crashes was nearly twice the rate for passenger car occupants.

Nearly two-thirds (59 percent) of the passenger vehicle occupants killed in traffic crashes in 2002 were unrestrained.

The intoxication rate for drivers of light trucks involved in fatal crashes in 2002 (23 percent) was slightly higher than that for passenger car drivers (22 percent).

Utility vehicles had the highest rollover involvement rate of any vehicle type in fatal crashes — 36 percent, as compared with 26 percent for pickups, 18 percent for vans, and 16 percent for passenger cars.

Utility vehicles also had the highest rollover rate for passenger vehicles in injury crashes — 10 percent, compared with 7 percent for pickups, 4 percent for vans, and 3 percent for passenger cars.

Driver Age

There are 26 million people age 70 years and older in the United States. In 2002, this age group made up 9.0 percent of the total U.S. resident population, compared with 8.8 percent in 1992. From 1992 to 2002, the growth rate for this older segment of the population was 27 percent higher than the growth rate of the total population.

In 2002, 154,000 older individuals were injured in traffic crashes, accounting for 5 percent of all the people injured in traffic crashes during the year. These older individuals made up 12 percent of all traffic fatalities, 12 percent of all vehicle occupant fatalities, and 17 percent of all pedestrian fatalities.

Older drivers involved in fatal crashes in 2002 had the lowest intoxication rate (5 percent) of all adult drivers.

In two-vehicle fatal crashes involving an older driver and a younger driver, the vehicle driven by the older person was more than twice as likely to be the one that was struck (66 percent and 30 percent, respectively). In 44 percent of these crashes, both vehicles were proceeding straight at the time of the collision. In 26 percent, the older driver was turning left — 7 times as often as the younger driver.

Youth

In 2002, 16- to 24-year-olds represented 25 percent of all traffic fatalities, compared with 6 percent for ages 0 to 15, 45 percent for ages 25 to 54, and 24 percent for ages 55 and over.

On a per population basis, drivers under the age of 25 had the highest rate of involvement in fatal crashes of any age group.

The intoxication rate for 16- to 20-year-old drivers involved in fatal crashes in 2002 was 17 percent. The highest intoxication rates were for drivers 21 to 24 and 25 to 34 years old (33 percent and 28 percent, respectively).

Almost one-fourth (23 percent) of all children between the ages of 5 and 9 years who were killed in motor vehicle traffic crashes were pedestrians. Nearly one-fifth (17 percent) of the traffic fatalities under age 16 were pedestrians.

Passenger vehicle occupants 10 to 24 years old involved in fatal crashes had the lowest restraint use rate (51 percent), and those over age 65 had the highest rate (72 percent).

Male/Female Fatal Crash Involvement

In 2001, the fatal crash involvement rate per 100,000 population was almost 3 times as high for male drivers as for females.

Males accounted for 69 percent of all traffic fatalities, 68 percent of all pedestrian fatalities, and 89 percent of all pedalcyclist fatalities in 2002.

The intoxication rate for male drivers involved in fatal crashes was 25 percent, compared with 12 percent for female drivers.

Among female drivers of passenger vehicles involved in fatal crashes in 2002, 28 percent were unrestrained at the time of the collision, compared with 42 percent of male drivers in fatal crashes.

Pedestrians

In 2002, 71,000 pedestrians were injured and 4,808 were killed in traffic crashes in the United States, representing 2 percent of all the people injured in traffic crashes and 11 percent of all traffic fatalities.

On average, a pedestrian is killed in a motor vehicle crash every 109 minutes, and one is injured every 7 minutes.

Alcohol involvement — either for the driver or the pedestrian — was reported in 46 percent of the traffic crashes that resulted in pedestrian fatalities. Of the pedestrians involved, 34 percent were intoxicated. The intoxication rate for the drivers involved was only 13 percent. In 5 percent of the crashes, both the driver and the pedestrian were intoxicated.

Pedalcyclists

In 2002, 662 pedalcyclists were killed and an additional 48,000 were injured in traffic crashes. Pedalcyclists made up 2 percent of all traffic fatalities and 2 percent of all the people injured in traffic crashes during the year.

Most of the pedalcyclists injured or killed in 2002 were males (75 percent and 89 percent, respectively), and most were between the ages of 5 and 44 years (82 percent and 64 percent, respectively).

More than one-fifth (22 percent) of the pedalcyclists killed in traffic crashes in 2002 were between 5 and 15 years old.
