Requirements for Earned Value Management for Major Information

Technology Investments

Earned Value Management (EVM) is a commonly-accepted mechanism for ensuring that projects are developed on-time and within their budget goals. ANSI/EIA-748-A is the federally accepted standard for EVM. OMB policy directs that all major IT investments with development, modernization or enhancement (D/M/E) spending must utilize EVM and be ANSI/EIA-748-A compliant. USDA is updating the Departmental Regulation 3130-006, Information Technology Earned Value Management to reflect this policy.

To implement this policy, the following actions are required for all major FY 2009 IT investments that are expected to have D/M/E spending in FY 2008:

- All contracts, existing or new, used for development efforts, must include a clause that requires the use of EVM in their contracts by July 31, 2007.
- All existing and new major IT investments must be certified to ANSI/EIA-748-A compliant by August 31, 2007. This typically means that they must complete an Integrated Baseline Review (IBR) to ensure that they are meeting the 32 standards within ANSI/EIA-748-A.
- Project plans and EVM data for all major investments with D/M/E spending are to be entered into WorkLenz by August 31, 2007. This will assist in our efforts to track EVM statistics and manage investments at the portfolio level.
- Agencies are to update WorkLenz with EVM data by the fifth work day of the month. All agencies with IT investments listed on the attachment, not currently reporting EVM, must report EVM through WorkLenz by September 7, 2007. This report is provided to OMB each month. Investments with cost or schedule variances greater then 10% will be required to provide a Correct Action Report to... OCIO.

USDA must begin reporting monthly EVM statistics for all major IT investments with D/M/E spending in September to coincide with the Exhibit 300 submissions of these major investments to OMB. EVM compliance is also part of Expanded Electronic
