The Grand Jury charges:

Count 1

On or about August 17, 2011, in the State and District of Colorado, the defendant, KEVIN BARRY MCAULEY a/k/a Michael Gabriel Hoverty, Keith Christopher Morony, Kevin Loughrin, Steven Maloney, Patrick Roche, knowingly possessed ammunition, that is a box of fifty rounds of Winchester .40 caliber ammunition, which had been transported in interstate and foreign commerce, while being an alien who was illegally and unlawfully in the United States.

Count 2

On or about August 17, 2011, KEVIN BARRY MCAULEY a/k/a Michael Gabriel Hoverty, Keith Christopher Morony, Kevin Loughrin, Steven Maloney, Patrick Roche, an alien (a person who is not a citizen or national of the United States), was found in the State and District of Colorado without having the express consent of the Attorney General and/or any statutorily authorized official for reapplication for admission to the United States, after previously having been excluded, deported, and removed from the United States on or about February 27, 2006.

In violation of Title 8, United States Code, Section 1326(a).
